THE MOTOR-VEHICLE (REGISTRATION-PLATE) REGULATIONS, 1934, AMENDMENT NO. 4.

Enacting authority : His Excellency the Governor-General in Council.
Act pursuant to which the regulations were made : Section 12 of the
Motor-vehicles Amendment Act, 1936.

Date on which the regulations were made : 16th day of September, 1936.

Date of notification in *Gazette* : 24th day of September, 1936.

REGULATIONS.

1. These regulations may be cited as the Motor-vehicle (Registration-plate) Regulations, 1934, Amendment No. 4.

2. These regulations shall be read together with and form part of the Motor-vehicle (Registration-plate) Regulations, 1934* (hereinafter called "the principal regulations").

3. These regulations shall come into force on the day following notification in the *Gazette* of the making hereof.

4. Every application for a certificate in terms of section 12 of the Motor-vehicles Amendment Act, 1936, shall be in the form marked R.M.V. 1 in the Schedule hereto.

5. Every application shall be accompanied by the prescribed fee, and may be delivered by hand or by post-letter to the Registrar or Deputy Registrar, and, if delivered by post, the fee may be paid by postal-note or postage-stamps.

6. Whether the application is delivered by hand or by post-letter the Registrar or Deputy Registrar may at his discretion deliver the certificate applied for by post-letter addressed to the applicant at the postal address set out in the application.

7. Every application shall relate only to a single vehicle.

8. Every certificate issued stating only the name and address of the registered owner of a vehicle shall be in the form marked R.M.V. 2 in the Schedule hereto, and the fee for every such certificate shall be 6d.

9. Every certificate issued stating other particulars than the name and address of the registered owner of a vehicle shall be in the form marked R.M.V. 3 in the Schedule hereto, and the fee for every such certificate shall be 1s.
