# THE MEAT REGULATIONS 1940, AMENDMENT NO. 11

# COBHAM, Governor-General

### ORDER IN COUNCIL

At the Government House at Wellington this 10th day of May 1961

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Meat Act 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. These regulations may be cited as the Meat Regulations 1940, Amendment No. 11, and shall be read together with and deemed part of the Meat Regulations 1940\* (hereinafter referred to as the principal regulations).
- 2. Regulation 3B of the principal regulations, as inserted by regulation 2 of the Meat Regulations 1940, Amendment No. 8, is hereby amended by revoking clause 3B: 5, and substituting the following clause:
- "3B: 5. In addition to the conditions referred to in clause 3: 8 of these regulations, as applied by this regulation, every meat-packing house licence shall be held subject to the condition that meat may be packaged for export in the premises to which the licence relates only if—
  - "(a) It has been passed by an Inspector as fit for human consumption;
  - "(b) It is of a standard approved by a Supervising Grader for the purposes of packaging for export; and

"(c) It has been derived from stock that has been slaughtered in a

meat-export slaughterhouse:

"Provided that meat derived from stock that has been slaughtered in an abattoir may be packaged for export with the prior consent in writing of the Minister, given on the recommendation of the New Zealand Meat Producers Board and on such terms and conditions as may be recommended by that Board."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

At present meat may not be packaged for export unless it has been derived from stock that has been slaughtered in a meat-export slaughterhouse. The amendment made by these regulations allows meat which has been derived from stock slaughtered in an abattoir to be so packaged with the prior consent in writing of the Minister, given on the recommendation of the New Zealand Meat Producers Board and on such terms and conditions as may be recommended by that Board.
