THE MEAT REGULATIONS 1969, AMENDMENT NO. 10

ORDER IN COUNCIL

At the Government House at Wellington this 18th day of October 1976

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Meat Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Meat Regulations 1969, Amendment No. 10, and shall be read together with and deemed part of the Meat Regulations 1969* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 25th day of October 1976.

2. Abattoir and slaughterhouse fees—(1) The Sixth Schedule to the principal regulations is hereby amended by omitting from clause 8 (as substituted by regulation 2 of the Meat Regulations 1969, Amendment No. 9) the item relating to pigs, and substituting the following item:

“Pigs 1.518.”

(2) The said Sixth Schedule is hereby further amended by revoking paragraph (b) and paragraph (c) of clause 9 (as substituted by regulation 2 of the Meat Regulations 1969, Amendment No. 9), and substituting the following paragraphs:

“(b) For the purpose of paragraph (a) of this clause, every head of cattle other than calves shall be reckoned as 5 head of stock:

“(c) The appropriate fee prescribed by paragraph (a) of this clause shall be increased for each head of stock slaughtered during any period mentioned in that paragraph, as follows:

Cattle (including calves exceeding 27 kg dressed weight) or horses	0.125
Calves, not exceeding 27 kg dressed weight	0.03
Pigs	0.705
Sheep, lambs, and goats	0.0025.”

3. Revocation—The Meat Regulations 1969, Amendment No. 3 is hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the meat inspection fees payable in respect of stock slaughtered in abattoirs and slaughterhouses. The increase comprises the Federated Farmers levy and the tuberculosis reactor levy and, in respect of pigs, the amount payable to the Pork Industry Council.
