ORDER IN COUNCIL

At the Government Buildings at Wellington this 19th day of September 1977

Present:

THE HON. D. MACINTYRE PRESIDING IN COUNCIL

PURSUANT to the Meat Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Meat Regulations 1969, Amendment No. 11, and shall be read together with and deemed part of the Meat Regulations 1969\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1977.

**2. Abattoir, export slaughterhouse, and rural slaughterhouse fees**—The Sixth Schedule to the principal regulations is hereby amended by revoking clauses 8 and 9 (as substituted by regulation 2 of the Meat Regulations 1969, Amendment No. 9, and amended by regulation 2 of the Meat Regulations 1969, Amendment No. 10), and substituting the following clauses:

“8. Abattoir and export slaughterhouse fees (reg. 274)—

For every head of—

Cattle (including calves exceeding 27 kg dressed weight)	
or horses	2.727
Calves, not exceeding 27 kg dressed weight	0.374
Pigs	1.754
Sheep, lambs, and goats	0.2485

"9. Inspection of rural slaughterhouse (reg. 275)—

"(a) Where the number of stock slaughtered in any period of 3 months ending with the last day of September, December, March, or June—

Does not exceed 100 head	21.20
Exceeds 100 but does not exceed 250	36.60
Exceeds 250 but does not exceed 500	72.80
Exceeds 500 but does not exceed 750	109.20
Exceeds 750	145.65

"(b) The appropriate fee prescribed by paragraph (a) of this clause shall be increased, for every pig slaughtered during any such period, by 0.80

"(c) For the purposes of paragraph (a) of this clause every head of cattle other than calves shall be reckoned as 5 head of stock."

**3. Revocations**—The Meat Regulations 1969, Amendment No. 9, and the Meat Regulations 1969, Amendment No. 10, are hereby consequentially revoked.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations increase the meat inspection fees payable in respect of stock slaughtered in abattoirs and slaughterhouses. The increase comprises the Federated Farmers levy, the tuberculosis reactor levy, and, in respect of pigs, the levy payable to the Pork Industry Council.
