ORDER IN COUNCIL

At the Government House at Wellington this 26th day of June 1978

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Meat Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Meat Regulations 1969, Amendment No. 12, and shall be read together with and deemed part of the Meat Regulations 1969* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of July 1978.

2. Abattoir and slaughterhouse fees—(1) The Sixth Schedule to the principal regulations is hereby amended by omitting from clause 8 (as substituted by regulation 2 of the Meat Regulations 1969, Amendment No. 11) the item relating to pigs, and substituting the following item:
 “Pigs 2.454”.

(2) The said Sixth Schedule is hereby further amended by revoking paragraph (b) of clause 9 (as so substituted), and substituting the following paragraph:

“(b) The appropriate fee prescribed by paragraph (a) of this clause shall be increased, for every pig slaughtered during any such period, by 1.50”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the meat inspection fees payable in respect of pigs—

(a) From \$1.754 a head to \$2.454 in abattoirs and export slaughterhouses:

(b) From \$0.80 a head to \$1.50 in rural slaughterhouses.

The increase is payable to the Pork Industry Council.
