

THE MEAT REGULATIONS 1969, AMENDMENT NO. 3

Pursuant to the Meat Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Meat Regulations 1969, Amendment No. 3, and shall be read together with and deemed part of the Meat Regulations 1969* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of May

1973.

2. Abattoir, export slaughterhouse, and rural slaughterhouse fees—The Sixth Schedule to the principal regulations is hereby amended by revoking clauses 8 and 9 (as substituted by regulation 2 of the Meat Regulations 1969, Amendment No. 1), and substituting the following clauses:

"8. Abattoir and export slaughterhouse fees (reg. 274)—

"(a) Where the number of stock slaughtered in any period of 3 months ending with the last day of September.

December, March, or June—	
Does not exceed 100 head	10.70
Exceeds 100 but does not exceed 250	18.5 0
Exceeds 250 but does not exceed 500	36.80

"(b) The appropriate fee prescribed by paragraph (a) of	
this clause shall be increased, for every pig	
slaughtered during any such period, by	0.40
"(c) For the purposes of this clause, every head of cattle	
other than calves shall be reckoned as 5 head of	
stock."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations substitute a new scale of meat inspection fees, effective from 1 May 1973, for abattoirs, export slaughterhouses, and rural slaughterhouses. These fees include-

(a) The levy in respect of pigs payable to the New Zealand Dairy Board pursuant to section 84 of the Meat Act 1964.
(b) The levy payable to Federated Farmers of New Zealand Incorporated pursuant to section 84x of that Act.

(c) The levy of 8c per head payable in respect of cattle under the Tb Reactor Meat Disposal Scheme.
