# THE MEAT REGULATIONS 1969, AMENDMENT NO. 7

### ORDER IN COUNCIL

At the Government Buildings at Wellington this 28th day of January 1975

### Present:

THE HON. DR A. M. FINLAY PRESIDING IN COUNCIL.

Pursuant to the Meat Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Meat Regulations 1969, Amendment No. 7, and shall be read together with and deemed part of the Meat Regulations 1969\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 3rd day of

February 1975.

2. Abattoir and export slaughterhouse fees—The Sixth Schedule to the principal regulations is hereby amended by revoking clauses 8 and 9 (as substituted by regulation 2 of the Meat Regulations 1969, Amendment No. 3 and amended by regulation 2 of the Meat Regulations 1969, Amendment No. 6), and substituting the following clauses:

"8. Abattoir and export slaughterhouse fees (reg. 274)—

For every head of—
Cattle (including calves exceeding 27 kg dressed weight) or horses ...... 0.045
Calves, not exceeding 27 kg dressed weight ..... 0.03
Pigs ...... ..... ..... ..... 0.505
Sheep, lambs, and goats ..... ..... ..... ..... ...... 0.0025.

3. Revocation—The Meat Regulations 1969, Amendment No. 6 are hereby consequentially revoked.

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 3 February 1975, substitute substantially reduced scales of meat inspection fees.
