PURSUANT to the Meat Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Meat Regulations 1969, Amendment No. 8, and shall be read together with and deemed part of the Meat Regulations 1969* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Metric amendments—(1) The principal regulations are hereby amended in the manner indicated in the Schedule to these regulations.

(2) The principal regulations are hereby further amended by substituting the expression "82°c" for the expression "180°F (82°c)" in—

(a) Paragraph (a) of the definition of "to sterilise" in regulation 2: (b) Regulations 42 (4), 50, 57 (4), 169, 208 (3), 211 (2), 213 (1),

and regulation 255 (1) (d).
