

THE MEAT (PAYMENTS) REGULATIONS 1990, AMENDMENT NO. 4

ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Meat Act 1981, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Meat (Payments) Regulations 1990, Amendment No. 4, and shall be read together with and deemed part of the Meat (Payments) Regulations 1990* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of November 1993.
- 2. New Schedules substituted—(1) The principal regulations are hereby amended by revoking the First and Second Schedules (as substituted by regulation 4 (1) of the Meat (Payments) Regulations 1990,

Amendment No. 3), and substituting the Schedules set out in the Schedule to these regulations.

(2) Regulation 4 of the Meat (Payments) Regulations 1990, Amendment No. 3, is hereby consequentially revoked.

3. Revocation of spent order—The Meat (Recovery of Inspection Costs) Order (No. 2) 1987* is hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 November 1993, increase the amounts of certain levies.

The levy per head of cattle (other than cows and calves) is increased from \$7.2244 to \$7.8919; and the levy per cow is increased from \$7.6378 to \$8.3053.

The opportunity has been taken to revoke the Meat (Recovery of Inspection Costs) Order (No. 2) 1987, a spent Order in Council that dealt with the matters now dealt with by the Meat (Payments) Regulations 1990.
