THE MAXIMUM RETAIL PRICES MARKING NOTICE 1973

PURSUANT to regulation 13A (1B) of the Stabilisation of Prices Regulations 1972* (as inserted by regulation 10 of the Stabilisation of Prices Regulations 1972, Amendment No. 2, and amended by regulation 5 of the Stabilisation of Prices Regulations 1972, Amendment No. 4), the Minister of Trade and Industry hereby gives the following notice.

NOTICE

1. Title—This notice may be cited as the Maximum Retail Prices Marking Notice 1973.

2. Maximum retail price emblems—(1) The provisions of subclause (1B) of the said regulation 13A shall apply with respect to the classes of goods specified in the First Schedule to this notice.

(2) The emblem specified in the said subclause (1B) (which shall be conspicuously printed and legible) shall be in the form set out in the Second Schedule to this notice.

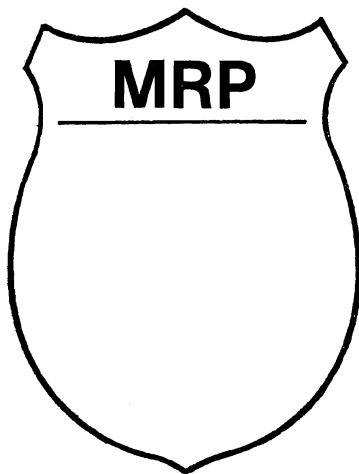
FIRST SCHEDULE

GOODS THE LABELS FOR WHICH ORDERED AFTER 23 JULY 1973
MUST INCLUDE PRESCRIBED EMBLEM

ALL goods of the following kinds which are manufactured or packed in New Zealand:

- Baby foods, canned and bottled.
- Baked beans.
- Biscuits.
- Breakfast foods and cereals.
- Cheese, processed and pre-packed.
- Cocoa and cocoa-based preparations.
- Coffee, including instant coffee, coffee beans, coffee and chicory, coffee essence, and coffee and milk.
- Confectionery, including chocolate.
- Crispbread.
- Fish, canned.
- Flour, standard.
- Fruits, dried or evaporated (excluding crystallised or drained fruits and synthetic fruits).
- Fruit and fruit pulp, canned or bottled.
- Fruit juices, canned or bottled.
- Honey, packed.
- Jams and marmalade of all types.
- Malted milk.
- Margarine.
- Meat, canned (with or without other ingredients).
- Meat and vegetable extracts.
- Peanut butter.
- Rice, including ground rice.
- Soap, soap powders, and detergents.
- Soups, canned, and soup powders.
- Spaghetti, canned.
- Tea.
- Vegetables, dried, canned, or frozen, with or without other ingredients.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice prescribes classes of goods for the purposes of regulation 13A (1B) of the Stabilisation of Prices Regulations 1972, which provides that labels ordered after 23 July 1973 for packages intended to contain goods of such kinds as the Minister prescribes are to contain an emblem in a form prescribed by the Minister.

The notice also prescribes the form of that emblem.

Issued under the authority of the Regulations Act 1936.

Date of notification in *Gazette*: 12 July 1973.

This notice is administered in the Department of Trade and Industry.
