# THE MEDICAL RADIATION TECHNOLOGISTS REGULATIONS 1995, AMENDMENT NO. 1

## ORDER IN COUNCIL

## HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 40 of the Medical Auxiliaries Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Medical Radiation Technologists Regulations 1995, Amendment No. 1, and shall be read together with and deemed part of the Medical Radiation Technologists Regulations 1995\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 8th day of August 1996.

**2. Exceptions to statutory prohibition**—(1) Regulation 11 (1) of the principal regulations is hereby amended by revoking paragraph (e), and substituting the following paragraph:

"(e) The performance of medical radiation technology by a named person who has been approved by the Board."

(2) Regulation 11 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclause:

"(2) Any approval under subclause (1) (e) of this regulation may be—

"(a) Limited to a specified period of time:

"(b) Subject to such conditions as the Board thinks fit."

**3. First Schedule amended**—(1) The First Schedule to the principal regulations is hereby amended by revoking items 1 and 2.

(2) The First Schedule to the principal regulations is hereby amended by revoking item 7, and substituting the following item:

"7. A National Diploma in Medical Diagnostic Imaging issued by the Authority for Vocational Awards on the recommendation of the New Zealand Conjoint Board of the Royal Australasian College of Radiologists and the New Zealand Institute of Medical Radiation Technology Incorporated."

(3) The First Schedule to the principal regulations is hereby amended by revoking item 8, and substituting the following item:

"8. A National Diploma in Medical Diagnostic Imaging issued by the New Zealand Conjoint Board of the Royal Australasian College of Radiologists and the New Zealand Institute of Medical Radiation Technology Incorporated."

(4) The First Schedule to the principal regulations is hereby amended by revoking item 11, and substituting the following item:

"11. The undergoing of a course of training and the passing of an examination or examinations that, in the opinion of the Board, are substantially equivalent to the course of training and examination or examinations required for registration under any of items 4, 5, 8, or 9 of this Schedule."

**4. Second Schedule amended**—The Second Schedule to the principal regulations is hereby amended by revoking form 1, and substituting the form 1 set out in the Schedule to these regulations.

## NOTES

1. Those holding Diplomas should enclose a certified photocopy of their Diploma. The photocopy should be certified by a Justice of the Peace, a solicitor, or a Registrar or Deputy Registrar of the High Court or a District Court, after sighting the original Diploma.

2. Those not holding Diplomas should refer to the date of their examination and provide proof of the results of that examination.

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 8 August 1996, amend the Medical Radiation Technologists Regulations 1995.

The main change made by the amendments relates to regulation 11 of the principal regulations. Regulation 11 contains exceptions to the prohibition against performing medical radiation technology by unregistered persons. One exception is the performance of medical radiation technology by a named person, who has been approved by the Medical Radiation Technologists Board, during his or her employment by a named hospital or Government Department. The amendments recast this exception to refer to the performance of medical radiation technology by a named person who has been approved by the Medical Radiation Technologists Board.

These regulations also make a number of changes to the First and Second Schedules to the principal regulations.
