PURSUANT to section 42 of the Motor Spirits Distribution Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. **Title and commencement**—(1) These regulations may be cited as the Motor Spirits Distribution Regulations 1955, Amendment No. 7, and shall be read together with and deemed part of the Motor Spirits Distribution Regulations 1955* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1981.

2. **Application for wholesaler's licence**—The principal regulations are hereby amended by revoking regulation 9, and substituting the following regulation:

“9. Every application for a wholesaler's licence shall be accompanied by a fee of \$75, and every application for the transfer of a wholesaler's licence, or for variation of the conditions of a wholesaler's licence, shall be accompanied by a fee of \$30.”

3. Wholesaler's annual licence fee—The principal regulations are hereby amended by revoking regulation 10, and substituting the following regulation:

"10. In respect of each wholesaler's licence there shall be payable by the licensee, as an annual licence fee, the sum of \$40 for every million litres or part of a million litres of motor spirits sold by the licensee during the year that ended with the 31st day of December immediately preceding the date on which the fee becomes payable."

4. Retailer's annual licence fee—The principal regulations are hereby further amended by revoking regulation 13 (as substituted by regulation 3 (1) of the Motor Spirits Distribution Regulations 1955, Amendment No. 6), and substituting the following regulation:

"13. In respect of each retailer's licence there shall be payable by the licensee an annual licence fee as follows:

For a licence to sell motor spirits through a pump or pumps only	\$40
For a licence to sell motor spirits through pumps and otherwise than through pumps	\$50
For a licence to sell motor spirits in any manner except through pumps	\$50."

5. Application fee for retailer's licence—The principal regulations are hereby further amended by revoking regulation 15 (as substituted by regulation 4 (1) of the Motor Spirits Distribution Regulations 1955, Amendment No. 6), and substituting the following regulation:

"15. Every application for a retailer's licence shall be accompanied by a fee of \$75, and every application for the transfer of a retailer's licence, or for variation of the conditions of a retailer's licence, shall be accompanied by a fee of \$30."

6. Duplicate licence fee—Regulation 17 of the principal regulations (as amended by regulation 5 of the Motor Spirits Distribution Regulations 1955, Amendment No. 6) is hereby amended by omitting the expression "\$2", and substituting the expression "\$4".

7. Consequential revocations—Regulations 2 to 5 of the Motor Spirits Distribution Regulations 1955, Amendment No. 6 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1981, increase the fees payable under the Motor Spirits Distribution Regulations 1955 as follows:

- (a) The application fee for a wholesaler's licence is increased from \$20 to \$75, and the fee for transfer or variation of a wholesaler's licence is increased from \$20 to \$30:

- (b) The annual fee for a wholesaler's licence is increased from \$20 to \$40 for every million litres or part of a million litres of motor spirits sold:
- (c) The annual fee for a retailer's licence to sell motor spirits through pumps only is increased from \$20 to \$40:
- (d) The annual fee for a retailer's licence to sell motor spirits other than through pumps (whether or not in conjunction with sales through pumps) is increased from \$30 to \$50:
- (e) The application fee for a retailer's licence is increased from \$50 to \$75, and the fee for transfer or variation of a retailer's licence is increased from \$20 to \$30:
- (f) The fee for a duplicate licence is increased from \$2 to \$4.
