

MOTOR SPIRITS DISTRIBUTION (RETURNS) REGULATIONS 1969

ORDER IN COUNCIL

At the Government House at Wellington this 1st day of September 1969

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Motor Spirits Distribution Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Motor Spirits Distribution (Returns) Regulations 1969.
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- 2. Returns by wholesalers—(1) Every wholesaler shall by the 31st day of December 1969 forward to the Licensing Authority a return in the form in the First Schedule hereto setting forth in respect of each retailer and each bulk consumer a complete statement of particulars for the year ended with the 31st day of December 1968.
- (2) Every wholesaler shall by the 1st day of April in each year forward to the Licensing Authority a return in the form in the First Schedule hereto setting forth in respect of each retailer and each bulk consumer a complete statement of particulars for the preceding year commencing with the 1st day of January and ending with the 31st day of December.
- 3. Returns by retailers—(1) Every retailer shall by the 31st day of December 1969 forward to the Licensing Authority a return in the form

in the Second Schedule hereto setting forth in respect of the retailer a complete statement of particulars for the year ended with the 31st day of December 1968.

- (2) Every retailer shall by the 1st day of April in each year forward to the Licensing Authority a return in the form in the Second Schedule hereto setting forth in respect of the retailer a complete statement of particulars for the preceding year commencing with the 1st day of January and ending with the 31st day of December.
- 4. Additional returns—Any return required by these regulations shall be in addition to any return from any wholesaler or retailer relating respectively to such matters specified in paragraphs (a) to (h) of subsection (1) and paragraphs (a) to (h) of subsection (1A) of section 21A of the Motor Spirits Distribution Act 1953 as the Licensing Authority may require.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations are made under the Motor Spirits Distribution Act 1953, and prescribe the form of return to be made by a wholesaler in respect of motor spirits sold by him to each retailer and bulk consumer, and the form of return to be made by a retailer of motor spirits. Returns for the year ended with 31 December 1968 are to be made by 31 December 1969 and returns for each succeeding year commencing with 1 January and ending with 31 December must be made by 1 April in the following year.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 4 September 1969.
