HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 3 of the Motor Spirits (Regulation of Prices) Act, 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

**REGULATIONS**

1. (1) These regulations may be cited as the Motor Spirits Prices Regulations 1942, Amendment No. 22, and shall be read together with and deemed part of the Motor Spirits Prices Regulations 1942\* (hereinafter called the principal regulations).

(2) These regulations shall come into force on the day following the date of their notification in the *Gazette*.

2. The Third Schedule to the principal regulations is hereby amended—

(a) By omitting the words “Sales Area 41 (Set of Differentials Applicable: No. 19)” and the description of Sales Area 41 and substituting the following words:—

“SALES AREA 41 (SET OF DIFFERENTIALS APPLICABLE: No. 19)

“All that area in the Hawke's Bay Land District bounded by a line commencing at a point on the Napier-Taupo Road 40 chains north of Te Pohue; running thence north-easterly along a right line to a road intersection at the southernmost corner of Section 3, Block XI, Maungaharuru Survey District; thence south-easterly along a right line running in the direction of Tangoio Bluff to a point 200 chains from the said Tangoio Bluff; thence south-westerly along a right line to the northernmost corner of Section 28, Rissington Settlement, situated in Block XIII, Puketapu Survey District; thence southerly along a right line to a point 80 chains north of the Opapa Post Office; thence southerly

generally along a line parallel to and 80 chains west of the Napier-Woodville Main Road to a point 80 chains from the northern boundary of the Borough of Waipawa; thence along lines parallel to and distant 80 chains from the northern, western, and southern boundaries of the Borough of Waipawa; thence again southerly and westerly along lines parallel to and distant 80 chains from the Napier-Woodville Main Road to its intersection with the northern boundary of Section 31, Block V, Takapau Survey District; thence northerly along a right line to a point 40 chains due west of the Makeratu Post Office; thence along a right line to the road intersection at the north-eastern corner of Section 5, Block XIII, Maraekakaho Survey District; thence along a right line to a point 40 chains due west of the Kereru Post Office; thence along a right line to a point on the Napier-Taupo Road 40 chains north of Te Pohue, the point of commencement.

(b) By omitting the words "Sales Area 42 (Set of Differentials Applicable: No. 12)" and the description of Sales Area 42, and substituting the following words:—

"SALES AREA 42 (SET OF DIFFERENTIALS APPLICABLE: NO. 12)

"All that area in the Hawke's Bay Land District bounded on the west by Area 41 hereinbefore described from a point 80 chains north of the Opapa Post Office to the easternmost corner of the aforesaid Area 41; thence by a line proceeding south-easterly along the production of the north-eastern boundary of Area 41 aforesaid to Tangoio Bluff, thence southerly along the sea coast to the middle of the mouth of the Esk River; thence westerly generally up the middle of that river to the middle of the Waipunga Road Bridge; thence south-westerly along a right line to the north-western corner of Section 77, Block XV, Puketapu Survey District; thence southerly along a right line to the confluence of the Ohiwia Stream and the Ngaruroro River, and a right line to the south-eastern corner of Turamoe No. 3 Block; thence easterly along a right line passing through the easternmost corner of Section 32, Block IV, Te Mata Survey District, to the Tukituki River; thence up the middle of the Tukituki River to its intersection with a right line running from a point on the Elsthorpe-Havelock North Road 40 chains north of the Elsthorpe Post Office to a point 80 chains north of the Opapa Post Office; thence along that line to the point of commencement.

(c) By omitting the words "Sales Area 43 (Set of Differentials Applicable: No. 7)" and the description of Sales Area 43, and substituting the following words:—

"SALES AREA 43 (SET OF DIFFERENTIALS APPLICABLE: NO. 7)

"All that area in the Hawke's Bay Land District bounded on the north, west, and south by Area 42 hereinbefore described from the middle of the mouth of the Esk River to the Tukituki River; thence on the east by a right line running through the northernmost corner of Section 157, Block III, Clive Survey District, to the sea coast, and by the sea coast to the middle of the mouth of the Esk River the point of commencement.

(d) By omitting the words "Sales Area 47 (Set of Differentials Applicable: No. 19)" and the description of Sales Area 47, and substituting the following words:—

"SALES AREA 47: (SET OF DIFFERENTIALS APPLICABLE: NO. 19)

"All that area in the Hawke's Bay and Wellington Land Districts bounded on the north-east by Areas 45 and 46 from a point on the northern boundary of Section 31, Block V, Takapau Survey District, distant 80 chains from the Napier-Woodville Main Highway, to the railway line at the northernmost corner of Section 2,

Block V, Takapau Survey District; thence southerly by a right line to the road at the northernmost corner of Section 13, Block V, Mangatoro Survey District; thence south-westerly by a right line to a point on the Makuri-Aohanga Road at the southernmost corner of Section 4, Block XIV, Makuri Survey District; thence south-westerly by a right line to the northernmost corner of Section 200, Block XII, Mangaone Survey District; thence northerly by a right line to the road at the northernmost corner of Section 179, Block VII, Woodville Survey District; thence north-easterly generally by lines parallel to and 80 chains south-east of the Napier-Woodville Main Road to a point 80 chains from the boundary of the Borough of Dannevirke; thence by lines parallel to and distant 80 chains from the eastern, northern, and western boundaries of the Borough of Dannevirke; thence westerly by a right line to the intersection of Otamaraho and Kumeti Roads; thence due south to a point 80 chains distant from the Napier-Woodville Main Road; thence south-westerly by lines parallel to and distant 80 chains from the Napier-Woodville Main Road to a point 80 chains from the Borough of Woodville; thence by a right line parallel to and 80 chains from the northern boundary of the Borough of Woodville to a point in line with the western boundary of the said borough; thence by a right line to a point 40 chains west of Ruaroa Post Office; thence by a right line to a point 40 chains west of Umutaoroa Post Office; thence by a right line to a point on the northern boundary of Section 31, Block V, Takapau Survey District, distant 80 chains from the Napier-Woodville Main Highway, the point of commencement.

(f) By inserting after the description of Sales Area 88, the following :—

" SALES AREA 88A (SET OF DIFFERENTIALS APPLICABLE: No. 19)

" All that area in the Canterbury Land District situated within a radius of 80 chains from the Balmoral Railway Station.

" Balmoral.

" SALES AREA 88B (SET OF DIFFERENTIALS APPLICABLE: No. 23)

" All that area in the Canterbury Land District situated within a radius of 80 chains from the Cheviot Post Office.

" Cheviot.

" SALES AREA 88C (SET OF DIFFERENTIALS APPLICABLE: No. 22)

" All that area in the Canterbury Land District situated within a radius of 80 chains from the Culverden Post Office.

“ All that area in the Canterbury Land District situated within a radius of 80 chains from the Parnassus Post Office.

“ All that area in the Canterbury Land District situated within a radius of 80 chains from the Rotherham Post Office.

“ SALES AREA 88K (SET OF DIFFERENTIALS APPLICABLE : No. 16)

“ All that area in the Canterbury Land District situated within a radius of 80 chains from the Scargill Post Office.

“ Scargill.

“ SALES AREA 88L (SET OF DIFFERENTIALS APPLICABLE : No. 7)

“ All that area in the Canterbury Land District situated within a radius of 80 chains from the Waipara Post Office, excepting thereout that portion of the area included in Sales Area 88.

“ Waipara.

“ SALES AREA 88M (SET OF DIFFERENTIALS APPLICABLE : No. 25)

“ All that area in the Canterbury Land District situated within a radius of 80 chains from the Waiiau Post Office.

“ Waiiau.

“ SALES AREA 88N (SET OF DIFFERENTIALS APPLICABLE : No. 14)

“ All that area in the Canterbury Land District situated within a radius of 80 chains from the Waikari Post Office.

“ Waikari.”

3. Paragraphs (a) and (b) of regulation 4 of the Motor Spirits Prices Regulations 1942, Amendment No. 6, and paragraphs (a), (b), and (c) of regulation 4 of the Motor Spirits Prices Regulations 1942, Amendment No. 7, are hereby revoked.
