**THE MOTOR SPIRITS PRICES REGULATIONS 1942,
AMENDMENT NO. 31**

ORDER IN COUNCIL

At the Government House at Wellington this 17th day of December 1956

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Motor Spirits (Regulation of Prices) Act 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the recommendation of the Minister of Industries and Commerce, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Motor Spirits Prices Regulations 1942, Amendment No. 31, and shall be read together with and deemed part of the Motor Spirits Prices Regulations 1942* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. The Second Schedule to the principal regulations is hereby amended by adding to the table of differentials the following item:

Set of Differentials No.	Scale A By Wholesaler in General	Scale B Wholesale to Bulk Consumer	Scale D Retail General
"45	2	2	1½"

3. (1) The Third Schedule to the principal regulations is hereby amended as follows:

- (a) By omitting from that part of the Schedule that relates to Sales Area 106 the words "Set of Differentials Applicable: No. 23", and substituting the words "Set of Differentials Applicable: No. 22":

- (b) By omitting from that part of the Schedule that relates to Sales Area 107 the words "Set of Differentials Applicable: No. 22", and substituting the words "Set of Differentials Applicable: No. 19":
 - (c) By omitting from that part of the Schedule that relates to Sales Area 108 the words "Set of Differentials Applicable: No. 19", and substituting the words "Set of Differentials Applicable: No. 16":
 - (d) By omitting from that part of the Schedule that relates to Sales Area 109 the words "Set of Differentials Applicable: No. 17", and substituting the words "Set of Differentials Applicable: No. 45":
 - (e) By omitting from that part of the Schedule that relates to Sales Area 111 the words "Set of Differentials Applicable: No. 25", and substituting the words "Set of Differentials Applicable: No. 23".
- (2) The Third Schedule to the principal regulations is hereby further amended by omitting so much as relates to Sales Area 110, and substituting the following:

"SALES AREA 110 (SET OF DIFFERENTIALS APPLICABLE: NO. 8)

"All that area in the Southland Land District bounded by a line commencing at the intersection of the Waimatua or Duck Creek with the eastern boundary of the City of Invercargill and proceeding southerly along that boundary to the south-eastern corner of that city; thence along a right line to a point on Mokotua Stream 5 chains eastward of the Invercargill-Bluff Road; thence along lines parallel to and 5 chains distant from that road to its crossing of the railway; thence along a right line to the shore of Bluff Harbour at a point 10 chains east of Greenhills Post Office; thence along that shore to a point in line with the south-eastern boundary of Section 22, Block I, Campbelltown Hundred; thence south-westerly to and along that boundary and its production to the sea coast; thence northerly along the sea coast and the eastern shore of New River Harbour to the western boundary of the City of Invercargill; thence northerly generally along that boundary and easterly along the northern boundary of that City to a point 100 links from the Invercargill-Waikivi Road; thence northerly along lines parallel to and 100 links distant from that road to a point 40 chains distant from the Waikivi Post Office; thence due west to a point 39 chains from the eastern side of that road, due north for a distance of 80 chains, due east for a distance of 80 chains, due south for a distance of 80 chains, and due west to a point 100 links from the Invercargill-Waikivi Road; thence southerly along lines parallel to and 100 links distant from that road to the northern boundary of the City of Invercargill; thence easterly and southerly along the northern and eastern boundaries of that City to the point of commencement.

“SALES AREA 110A (SET OF DIFFERENTIALS APPLICABLE: No. 6)

“All that area in the Southland Land District bounded by a line commencing on the western shore of Bluff Harbour at a point in line with the south-eastern boundary of Section 22, Block I, Campbelltown Hundred, and proceeding south-easterly along that shore, and south-westerly and north-westerly along the sea coast to a point in line with the south-eastern boundary of Section 22 aforesaid; thence north-easterly to and along that boundary to the point of commencement.
