PURSUANT to the Motor Spirits (Regulation of Prices) Act 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the recommendation of the Minister of Industries and Commerce, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Motor Spirits Prices Regulations 1942, Amendment No. 52, and shall be read together with and deemed part of the Motor Spirits Prices Regulations 1942* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. The Third Schedule of the principal regulations (as amended by regulation 2 of the Motor Spirits Prices Regulations 1942, Amendment No. 51) is hereby further amended by omitting so much thereof as relates to Sales Area 91A, and substituting the following:

“SALES AREA 91A (SET OF DIFFERENTIALS APPLICABLE: NO. 1)

“All that area in the Canterbury Land District comprising the City of Timaru as described in *Gazette*, 1960, Vol. I, page 144, the additions to the said city as described in *Gazette*, 1963, Vol. I, page 10, and also all that area to the north of the City of Timaru bounded by a line commencing at a point in the middle of Pages Road, on the production of the western boundary of Lot 1, D.P. 10091, the said point being on the boundary of the City of Timaru as described in *Gazette*, 1963, Vol. I, page 10, and proceeding north-easterly along a right line to the easternmost corner of Lot 3, D.P. 558, situated in Block VIII, Arowhenua Survey District; thence due east along a right line to the mean high-water mark of the sea; thence south-easterly along that mean high-water mark and across the mouth of Taitarakahi Creek, to the mean high-water mark of the sea, near Dashing Rocks, being a point on the boundary of the City of Timaru as described in *Gazette*, 1960, Vol. I, page 144; thence westerly generally along the boundary of the said city to the point of commencement.
