Pursuant to the Motor Spirits (Regulation of Prices) Act 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Motor Spirits Prices Regulations 1970, Amendment No. 23, and shall be read together with and deemed part of the Motor Spirits Prices Regulations 1970* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 17th day of May 1979.
- 2. New Schedule substituted—The principal regulations are hereby amended by revoking the Schedule (as substituted by regulation 2 of the Motor Spirits Prices Regulations 1970, Amendment No. 22), and substituting the Schedule set out in the Schedule to these regulations.
- 3. Revocation—The Motor Spirits Prices Regulations 1970, Amendment No. 22, are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 17 May 1979, increase the retail price of motor spirits by 6.4c per litre for standard grade and 7c per litre for premium grade. The wholesale price is increased by 6.2c per litre for standard grade and 6.8c per litre for premium grade.

Note—The prices shown in the Schedule do not include any local authorities petroleum tax (maximum rate 0.66c per litre) which may be levied.
