PURSUANT to the Motor Spirits (Regulation of Prices) Act 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Motor Spirits Prices Regulations 1970, Amendment No. 27, and shall be read together with and deemed part of the Motor Spirits Prices Regulations 1970\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 12th day of February 1980.

**2. Interpretation**—Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term “local authority”, and substituting the following definition:

“‘Local authority’ means a Borough Council, Catchment Board, Catchment Commission, City Council, County Council, District Council, Domain Board, Drainage Board, Electric Power Board, Harbour Board, Hospital Board, Irrigation Board, Nasella Tussock Board, Pest Destruction Board, Railway Board, Regional Council, Regional Water Board, River Board, Town Council, Transport Board, United Council, Urban Fire Authority, or Water Supply Board; and includes the Auckland Regional Authority.”

**3. New Schedule substituted**—The principal regulations are hereby amended by revoking the Schedule (as substituted by regulation 2 of the Motor Spirits Prices Regulations 1970, Amendment No. 26), and substituting the Schedule set out in the Schedule to these regulations.

**4. Revocation**—The Motor Spirits Prices Regulations 1970, Amendment No. 26, are hereby consequentially revoked.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 12 February 1980, amend the Motor Spirits Prices Regulations 1970.

*Regulation 2* substitutes a new definition of the term "local authority". The new definition has the effect of adding District Councils, Regional Councils, and United Councils to the classes of local authorities that are local authorities within the meaning of the principal regulations. Underground water authorities are deleted from those classes of local authorities. (Note—The principal regulations, by virtue of regulation 11 (c), do not apply to the sale of any motor spirits to a local authority.)

*Regulation 3* increases the wholesale and retail prices of motor spirits. Wholesale general prices are increased by 4.83c per litre. Bulk consumer and retail general prices are increased by 5c per litre. The new prices are shown in the Schedule to the regulations. (Note—The prices shown in the Schedule do not include any local authorities petroleum tax (maximum rate 0.66c per litre) which may be levied.)

*Regulation 4* effects a consequential revocation.
