# ORDER IN COUNCIL

At the Government House at Wellington this 1st day of December 1980

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Motor Spirits (Regulation of Prices) Act 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Motor Spirits Prices Regulations 1970, Amendment No. 30, and shall be read together with and deemed part of the Motor Spirits Prices Regulations 1970\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.

# EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations reduce the wholesale price of motor spirits by 0.35c per litre NOTE—The prices shown in the Schedule do not include any local authorities petroleum tax (maximum rate 0.66c per litre) which may be levied.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 4 December 1980. These regulations are administered in the Ministry of Energy
