



THE MILK STATIONS REGULATIONS 1979, AMENDMENT NO. 1

ORDER IN COUNCIL

At the Government House at Wellington this 7th day of October 1985

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Dairy Industry Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Milk Stations Regulations 1979, Amendment No. 1, and shall be read together with and deemed part of the Milk Stations Regulations 1979* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day of October 1985.

2. Fees—(1) The principal regulations are hereby amended by inserting, after regulation 51, the following regulation:

“51A. (1) There shall be paid by the occupier of a depot or milk station, in respect of every inspection of that depot or station under section 5 of the Act, a fee equal to one-third of an amount calculated in accordance with the Second Schedule to these regulations.

“(2) There shall be paid by the occupier of a depot or milk station, in respect of every test specified in the first column of the Fifth Schedule to

these regulations that is carried out as part of or pursuant to any inspection under section 5 of the Act of that depot or station, the fee specified in the second column of that schedule opposite the reference to that test.”

(2) The principal regulations are hereby amended by adding the schedules set out in the Schedule to these regulations.

(3) The principal regulations are hereby consequentially amended—

(a) By inserting in regulation 7 (b), before the word “Schedule”, the word “First”; and

(b) By inserting in the former only Schedule, before the word “SCHEDULE”, the word “FIRST”.
