PURSUANT to section 2 (2) of the Maritime Transport Act 1994, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Maritime Transport Act (Conventions) Order 1994.

(2) This order shall come into force on the 1st day of February 1995.

2. Maritime conventions declared to be conventions for purposes of Maritime Transport Act 1994—(1) Every convention specified in the Schedule to this order is hereby declared to be a convention for the purposes of Parts I to XV of the Maritime Transport Act 1994.

(2) Every amendment to any such convention that is specified in the Schedule to this order is hereby declared to form part of the convention for the purposes of Parts I to XV of the Maritime Transport Act 1994.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 February 1995, declares certain maritime conventions to which New Zealand is a party, together with specified amendments, to be conventions for the purposes of Parts I to XV of the Maritime Transport Act 1994.
