



**THE MAORI TRUST BOARD REGULATIONS 1960,
AMENDMENT NO. 4**

ORDER IN COUNCIL

At the Government House at Wellington this 20th day of December 1972

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Maori Trust Boards Act 1955, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Maori Trust Board Regulations 1960, Amendment No. 4, and shall be read together with and deemed part of the Maori Trust Board Regulations 1960* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Tuhoe-Waikaremoana Maori Trust Board—(1) The First Schedule to the principal regulations is hereby amended by omitting the words “Tuhoe Maori Trust Board . . . Twelve”, and substituting the words “Tuhoe-Waikaremoana Maori Trust Board . . . Fifteen.”

(2) The Second Schedule to the principal regulations is hereby amended by revoking so much thereof as relates to the Tuhoe Maori Trust Board, and substituting the following:

“Tuhoe-Waikaremoana Maori Trust Board	Four Four Four Three	The Ruatahuna division. The Maungapohatu division. The Ruatoki division. Those persons who are beneficiaries by virtue of section 11 of the Lake Waikaremoana Act 1971.”

(3) Notwithstanding the provisions of subclauses (1) and (2) of this regulation, the members of the Tuhoe-Waikaremoana Maori Trust Board in office at the commencement of these regulations shall, subject to section 16 of the Maori Trust Boards Act 1955, continue to hold office until the persons elected as members at the next election of members of the Board, or such of those persons as are qualified to be appointed, come into office.

3. Wairoa-Waikaremoana Maori Trust Board—(1) The First Schedule to the principal regulations is hereby amended by omitting the words “Wairoa Maori Trust Board . . . Seven”, and substituting the words “Wairoa-Waikaremoana Maori Trust Board . . . Ten”.

(2) The Second Schedule of the principal regulations is hereby amended by adding the following:

(3) Notwithstanding the provisions of subclauses (1) and (2) of this regulation, the members of the Wairoa-Waikaremoana Maori Trust Board in office at the commencement of these regulations shall, subject to section 16 of the Maori Trust Boards Act 1955, continue to hold office until the persons elected as members at the next election of members of the Board, or such of those persons as are qualified to be appointed, come into office.

4. Nomination forms for election—The Ninth Schedule to the principal regulations (as added by regulation 5 of the Maori Trust Board Regulations 1960, Amendment No. 2) is hereby amended by omitting the words “the Act”, and substituting the words “the Maori Trust Board Regulations 1960”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Maori Trust Board Regulations 1960.

Regulations 2 and 3 are consequential on the passing of the Lake Waikaremoana Act 1971. Regulation 2 provides for the appointment of 3 additional members to the Tuhoe-Waikaremoana Maori Trust Board. Regulation 3 provides for the appointment of 3 additional members to the Wairoa-Waikaremoana Maori Trust Board. Sectional representation on this Board is now provided for.

Regulation 4 effects a minor amendment.
