# ORDER IN COUNCIL

At the Government House at Wellington this 14th day of December 1981

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 148 of the Motor Vehicle Dealers Act 1975, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Motor Vehicle Dealers Regulations 1980, Amendment No. 1, and shall be read together with and deemed part of the Motor Vehicle Dealers Regulations 1980\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of January 1982.

2. New form substituted in Second Schedule to principal regulations—(1) The Second Schedule to the principal regulations is hereby amended by revoking Form 8, and substituting the Form 8 set out in the First Schedule to these regulations.

(2) The Second Schedule to the principal regulations is hereby further amended by revoking Form 20.

(3) The First Schedule to the principal regulations is hereby amended—

(a) By inserting in the item relating to Form 8, after the word "licence",

the words "and one or more certificates of approval":

(b) By revoking the item relating to Form 20.

**3.** New scale of fees substituted in principal regulations—The principal regulations are hereby amended by revoking the Third Schedule, and substituting the Third Schedule set out in the Second Schedule to these regulations.
