HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 148 of the Motor Vehicle Dealers Act 1975, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Motor Vehicle Dealers Regulations 1980, Amendment No. 3, and shall be read together with and deemed part of the Motor Vehicle Dealers Regulations 1980* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of January 1992.

2. New scale of fees substituted in principal regulations—The principal regulations are hereby amended by revoking the Third Schedule (as substituted by regulation 3 of the Motor Vehicle Dealers Regulations

*S.R. 1980/33 Amendment No. 1: S.R. 1981/357 Amendment No. 2: S.R. 1987/352 1980, Amendment No. 2), and substituting the Third Schedule set out in the Schedule to these regulations.

3. Amount of goods and services tax included—The fees prescribed by the principal regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

4. Revocations—Regulation 3 of, and the Second Schedule to, the Motor Vehicle Dealers Regulations 1980, Amendment No. 2 are hereby consequentially revoked.
