



**THE MOTOR VEHICLE DEALERS REGULATIONS 1980,  
AMENDMENT NO. 4**

**ORDER IN COUNCIL**

At Wellington this 29th day of August 1994

Present:

THE HON. DOUG KIDD PRESIDING IN COUNCIL

PURSUANT to section 148 of the Motor Vehicle Dealers Act 1975, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Motor Vehicle Dealers Regulations 1980, Amendment No. 4, and shall be read together with and deemed part of the Motor Vehicle Dealers Regulations 1980\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1994.

**2. Amendments to forms**—(1) The Second Schedule to the principal regulations is hereby amended by omitting from form 4 the paragraph numbered 6, and substituting the following paragraph:

Amendment No. 1: S.R. 1981/357  
Amendment No. 2: S.R. 1987/352  
Amendment No. 3: S.R. 1991/253

“6. \*That I was, immediately before the 6th day of February 1976, the holder of a licence under the Motor Vehicle Dealers Act 1958.

OR

“\*That I have had, in the period of 3 years immediately preceding the date of my application for a licence, at least 2 years’ business experience, particulars of which experience are as follows:

“\*Delete whichever is not applicable.”

(2) The Second Schedule to the principal regulations is hereby further amended by omitting from form 5 the paragraphs numbered 8 and 9, and substituting the following paragraphs:

“8. \*That to the best of my knowledge and belief the said .....  
[The person named in paragraph 5 of this declaration as the company’s chief executive officer] was, immediately before the 6th day of February 1976, the holder of a licence under the Motor Vehicle Dealers Act 1958.

OR

“\*That to the best of my knowledge and belief the said .....  
[The person named in paragraph 5 of this declaration as the company’s chief executive officer] has had, in the period of 3 years immediately preceding the date of the company’s application for a licence, at least 2 years’ business experience, particulars of which experience are as follows:

“\*Delete whichever is not applicable.

“†9. \*That to the best of my knowledge and belief the said .....  
[The person named in paragraph 7 of this declaration as the person through whom the company intends to conduct its business as a motor vehicle dealer at its principal place of business] was, immediately before the 6th day of February 1976, the holder of a licence under the Motor Vehicle Dealers Act 1958.

OR

“\*That to the best of my knowledge and belief the said .....  
[The person named in paragraph 7 of this declaration as the person through whom the company intends to conduct its business as a motor vehicle dealer at its principal place of business] has had, in the period of 3 years immediately preceding the date of the company’s application for a licence, at least 2 years’ business experience, particulars of which experience are as follows:



(5) The Second Schedule to the principal regulations is hereby further amended by omitting from form 14 the paragraphs marked with an asterisk, and substituting the following paragraphs:

“\*I hereby further declare that to the best of my knowledge and belief the said ..... [*Name of proposed manager of the applicant’s principal place of business*] was, immediately before the 6th day of February 1976, the holder of a licence under the Motor Vehicle Dealers Act 1958.

OR

“\*I hereby further declare that to the best of my knowledge and belief the said ..... [*Name of proposed manager of the applicant’s principal place of business*] has had, in the period of 3 years immediately preceding the date of the company’s application for a licence, at least 2 years’ business experience, particulars of which experience are as follows:

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 October 1994, amend the forms that are prescribed for the purposes of the Motor Vehicle Dealers Act 1975. The amendments are consequential upon the enactment of the Motor Vehicle Dealers Amendment Act 1994, and reflect the fact that, from that date, applicants for the issue of a motor vehicle dealer’s licence will be required to have had, in the previous 3 years, not less than 2 years’ business experience. Currently, applicants for a licence are required to be registered salesmen and to have had, in the previous 3 years, not less than 2 years’ sales experience.
