ORDER IN COUNCIL

At the Government House at Wellington this 9th day of June 1975

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Motor Vehicles Indemnity Surcharge Regulations 1974, Amendment No. 1, and shall be read together with and deemed part of the Motor Vehicles Indemnity Surcharge Regulations 1974* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Indemnity surcharge—Regulation 3 (1) of the principal regulations is hereby amended by omitting the words "1st day of July 1974", and substituting the words "1st day of July 1975".
- 3. New scale of annual indemnity surcharge prescribed—The principal regulations are hereby amended by revoking the First Schedule, and substituting the First Schedule set out in the Schedule to these regulations.
- 4. Saving—Notwithstanding the foregoing provisions of these regulations, the annual indemnity surcharges payable under Part VIA of the Act and the classes of motor vehicles for the purposes of those surcharges shall, for the licensing year ending on the 30th day of June 1975, be the surcharges and classes respectively prescribed by the principal regulations as originally enacted, and any refund of the indemnity surcharge paid for the whole or part of that year in respect of any motor vehicle shall be the refund that would have been made if these regulations had not been enacted.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Motor Vehicles Indemnity Surcharge Regulations 1974 by substituting a new and increased scale of annual indemnity surcharges payable under Part VIA of the Transport Act 1962. The new scale, which also differs from the old scale in dividing motor cycles into two sizes, applies in respect of the licensing year commencing on 1 July 1975 and subsequent licensing years.
