

# THE NORTHLAND AREA HEALTH DISTRICT (TRIENNIAL GENERAL ELECTION AND BOUNDARIES) ORDER 1989

### ORDER IN COUNCIL

At Wellington this 17th day of July 1989

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 5A of the Area Health Boards Act 1983 (as inserted by section 4 of the Area Health Boards Amendment Act 1989) and to subsections (3) and (4A) of section 8 of the Area Health Boards Act 1983 (as amended by section 5 of the Area Health Boards Amendment Act 1989 and by section 5 of the Area Health Boards Amendment Act (No. 2) 1989), His Excellency the Governor-General, acting on the advice of the Minister of Health, and by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. Title and commencement—(1) This order may be cited as the Northland Area Health District (Triennial General Election and Boundaries) Order 1989.
- (2) Except as provided in clause 7 (2) of this order, this order shall come into force on the 18th day of July 1989.
- 2. Boundaries for triennial general election—It is hereby declared that, for the purposes of the triennial general election of members of local authorities to be held on the 14th day of October 1989 (as required by section 4 of the Local Elections and Polls Act 1976), the boundaries of the Northland Area Health District shall be deemed to be the boundaries of the land included within the Far North District, the Whangarei District, and the Kaipara District (being districts of territorial authorities named in the First Schedule to the Local Government Act 1974 (as substituted by clause 2 of the Local Government Act First Schedule Order (No. 2) 1989\*)).
- **3. Boundaries on 58th day after polling day**—It is hereby declared that, on the 58th day after polling day for the triennial general election referred to in clause 2 of this order, the boundaries declared by that clause shall become the boundaries of the Northland Area Health District.
- **4. Constituent districts**—It is hereby declared that, for the purposes of the triennial general election referred to in clause 2 of this order,—
  - (a) The area comprising the wards of the Far North District known as the Whangaroa Ward, the Hokianga Ward, and the Northern Ward shall be a constituent district of the Northland Area Health District; and
  - (b) The area comprising the wards of the Far North District known as the Kerikeri Ward, the Kaikohe Ward, and the Kawakawa Ward shall be a constituent district of the Northland Area Health District; and
  - (c) The area comprising the wards of the Whangarei District known as the Coastal Ward, the Hikurangi Ward, the Maungatapere Ward, and the Bream Bay Ward shall be a constituent district of the Northland Area Health District; and
  - (d) The area comprising the wards of the Whangarei District known as the Denby Ward and the Okara Ward shall be a constituent district of the Northland Area Health District; and
  - (e) The Kaipara District shall be a constituent district of the Northland Area Health District.
- 5. Number of representatives of constituent districts—The number of representatives on the Northland Area Health Board of each constituent district declared by clause 4 of this order shall be as specified in the Schedule to this order.
- **6. Conduct of elections**—(1) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (a) of this order—
  - (a) The Kaikohe Borough Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct

elections held within that constituent district before the 1st day of November 1989; and

- (b) The Far North District Council (as constituted by the Local Government (Northland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (2) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (b) of this order—
  - (a) The Kaikohe Borough Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Far North District Council (as constituted by the Local Government (Northland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (3) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (c) of this order—
  - (a) The Whangarei County Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Whangarei District Council (as constituted by the Local Government (Northland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (4) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (d) of this order—
  - (a) The Whangarei County Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Whangarei District Council (as constituted by the Local Government (Northland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- **7. Revocation**—(1) The Northland Area Health Board (Representation) Order 1986\* is hereby revoked.
  - (2) This clause shall come into force on the 11th day of December 1989.
