THE NEW-ZEALAND-GROWN FRUIT REGULATIONS 1940. AMENDMENT NO. 1.

ORDER IN COUNCIL.

At the Government House at Wellington, this 19th day of March, 1941.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Orchard and Garden Diseases Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the New-Zealand-grown Fruit Regulations 1940, Amendment No. 1.
- 2. These regulations shall be read together with and form part of the New-Zealand-grown Fruit Regulations 1940* (hereinafter called the principal regulations).
- 3. Regulation 21 of the principal regulations is amended by inserting, next after clause 21:2 thereof, the following additional clause-
- "21:2A. Notwithstanding the provisions of the last preceding clause of this regulation, the inspection fees payable in respect of every package of fruit which at any time after the 1st day of December, 1940, is or has been delivered to the Marketing Department for sale pursuant to the Lemon Marketing Regulations 1940† or the Apple and Pear Marketing Regulations 1940; shall be the following, that is to say-
 - "(a) For each package of the types referred to in paragraph (a) or paragraph (c) of the last preceding clause of this regulation, an inspection fee of $\frac{1}{2}$ d.:
 - "(b) For each package of the types referred to in paragraph (b) of the said clause, an inspection fee of $\frac{1}{4}$ d.

- 4. Regulation 21 of the principal regulations is further amended by revoking the words "the last preceding clause of this regulation" in clause 21:3 thereof, and substituting the following words and figures: "clause 21:2 of this regulation".
- 5. Regulation 21 of the principal regulations is further amended by inserting in clause 21:5 thereof, next after the word and figures "clause 21:2", the words and figures "or clause 21:2a".
- "clause 21:2", the words and figures "or clause 21:2A".

 6. Regulation 21 of the principal regulations is further amended by revoking the figures and word "1d. and ½d." in clause 21:8 thereof, and substituting the following figures and word "½d. and ¼d.".
