THE NEW-ZEALAND-GROWN FRUIT REGULATIONS 1940, AMENDMENT NO. 2.

ORDER IN COUNCIL.

At the Government House at Wellington, this 17th day of December, 1941.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Orchard and Garden Diseases Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the New-Zealand-grown Fruit Regulations 1940, Amendment No. 2.

2. These regulations shall be read together with and form part of the New-Zealand-grown Fruit Regulations 1940* (hereinafter referred to as the principal regulations).

3. These regulations shall come into force on the seventh day after

notification in the Gazette of the making hereof.

- 4. Regulation 1 of the principal regulations is amended by revoking the figures "1941" in clause 1:5 thereof, and substituting therefor the figures "1947".
- 5. Regulation 2 of the principal regulations is amended by revoking from the definition of marmalade grapefruit contained therein the words " or sour orange ".
- 6. Clause 5:2 of Regulation 5 of the principal regulations is amended as follows:-

(i) By revoking paragraph (f) thereof, and substituting therefor

the following paragraph:—

"(f) In the case of a package containing apples, pears, citrus fruit (other than mandarins) or stone-fruit which has been placed in cool-storage at any time before being offered for sale the words 'cool store' or any approved abbreviation of those words. This paragraph shall apply to any stonefruit whatever which at any time before the 1st day of November, 1947, has been placed in cool-storage before being offered for sale."

- (ii) By adding the following as paragraph (j) thereof:—
 - (j) In the case of a package containing citrus fruit (other than lemons and mandarins) which has been coloured off the tree by ethylene gas or by any other means the words "artificially coloured".
- 7. Regulation 17 of the principal regulations is amended as follows:—
 - (i) By revoking clause 17:4 thereof, and substituting therefor the following clause:—
 - "17:4. No. 1 grade cherries shall be properly packed and may, in respect of the top layers of fruit in any package, be faced level with the stems of the fruit concealed."
 - (ii) By revoking clause 17: 10 thereof, and substituting therefor the following clause:—
 - "17:10. No. 2 grade cherries shall be properly packed and may, in respect of the lop layers in any package, be faced level with the stems of the fruit concealed."
- **8.** Regulation 19 of the principal regulations is amended as follows:—
 - (i) By revoking the words "and grapefruit" in clause 19:1 thereof and substituting therefor the words "grapefruit and stone-fruit".
 - (ii) By adding to clause 19:2 thereof the following additional paragraph:—
 - "(c) In the case of stone-fruit, No. 1 or No. 2 grade."
 (iii) By inserting, next after the words "apples or pears" in
- clause 19: 3 thereof, the words "or No. 3 grade stone-fruit".

 9. Regulation 20 of the principal regulations is amended by revoking
- clause 20:9 thereof, and substituting therefor the following clause:—
 "20:9. Notwithstanding anything in the foregoing provisions of
 this regulation.—
 - "(a) No package containing stone-fruit shall be degraded by an Inspector by reason only of the presence of brown-rot on such fruit:
 - "(b) No package containing lemons shall be degraded by an Inspector by reason only of the presence of blue-mould or green-mould on such fruit, but the Inspector may require the owner to withdraw such package from sale for resorting or repacking so as to exclude from the package all fruit so affected."
