THE NELSON MILK DISTRICT ORDER 1960

At the Government House at Wellington this 30th day of November 1960

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Milk Act 1944, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the Nelson Milk District Order 1960.
- (2) This order shall come into force on the day after the date of its notification in the *Gazette*.
- 2. The Nelson Milk District, as constituted by the Nelson Milk District Constitution Order 1946,* shall hereafter consist of the areas described in the First Schedule hereto; and the boundaries of the said district shall be those specified in the said First Schedule.
- 3. The Milk Authority for the said district shall continue to be the Nelson City Council.
- 4. The Richmond Borough Council, the Motueka Borough Council, and the Waimea County Council shall each continue to be entitled to have a representative on the Milk Committee of the Nelson City Council and from time to time to nominate one person for that purpose.
- 5. The Nelson City Council shall from time to time appoint to the Milk Committee of the City Council the persons nominated by the Richmond Borough Council, the Motueka Borough Council, and the Waimea County Council pursuant to clause 4 hereof.
- 6. The Orders in Council specified in the Second Schedule hereto are hereby revoked.

SCHEDULES

FIRST SCHEDULE

THE NELSON MILK DISTRICT

ALL those areas situated in the Nelson Land District comprising:

Firstly: The City of Nelson (Gazette, 1958, page 1688, and Gazette, 1960, page 521), the Borough of Richmond (Gazette, 1917, page 4194), the Borough of Motueka (Gazette, 1939, page 2175), and parts of the Waimea County, and bounded generally as follows: Commencing at the easternmost corner of Section 1132, City of Nelson, being a point on the boundary of the said city, and proceeding easterly along that city boundary to its intersection with the eastern side of No. 6 State Highway; thence north-easterly generally along the generally southeastern side of the said highway to the westernmost corner of Section 4, Suburban North, in Block IX, Wakapuaka Survey District; thence southeasterly along the south-western side of the said Section 4 to the northernmost corner of Section 61, Suburban North, aforesaid; thence south-westerly and south-easterly along the north-western and southwestern boundaries of the said Section 61 to the western boundary of Section 11, District of Brook Street and Maitai, in Block IX, Wakapuaka Survey District; thence southerly along the western boundary of the said Section 11 to its intersection with the boundary of the City of Nelson, thence southerly generally along that city boundary to the northernmost corner of Section XI, Suburban South, in Block IV, Waimea Survey District; thence south-westerly along the generally north-western boundaries of the said Section XI and Sections XVII and VIII, Suburban South, in Block VIII, Waimea Survey District to the westernmost corner of the said Section VIII; thence westerly along a right line across Section X, to the northernmost corner of Section XIX, Waimea East, in Block VII, Waimea Survey District; thence southwesterly along the north-western boundary of the said Section XIX to its westernmost corner, being a point on the boundary of the Borough of Richmond; thence south-westerly and north-westerly along that borough boundary to the westernmost corner of Section 108, Waimea East, in Block VI, Waimea Survey District; thence north-westerly generally to and along the middle of No. 60 State Highway to its junction with Harley Road; thence north-easterly generally along the middle of Harley Road and its production to the high-water mark of Moutere Inlet; thence south-easterly and north-westerly generally along the high-water mark of Moutere Inlet to the entrance at the southern end of Jacketts Island; thence south-easterly and north-easterly generally to and along the high-water mark of Tasman Bay to the easternmost corner of that part of Section 3, Block II, Moutere Survey District, shown on D.P. 417; thence easterly along a right line to the northernmost point of Rabbit Island thence south-easterly along the north-eastern

shore of Rabbit Island to its easternmost point; thence due east to the boundary of the City of Nelson; thence north-easterly along that city boundary to the point of commencement.

Secondly: All that area, being portion of the Waimea County, bounded by a line commencing at a point on the shore of Tasman Bay in line with the northern boundary of Section 31, Block XII, Kaiteriteri Survey District; thence proceeding westerly generally to and along that boundary, the western boundary of the said Section 31 and the northern boundaries of Section 2 of 17 and Section 32, Block XII aforesaid, to the northwestern corner of the said Section 32, being a point on the western boundary of Block XII aforesaid; thence southerly along that boundary to the south-western corner of Section 101, Block XII aforesaid, being a point on the northern boundary of Block X, Kaiteriteri Survey District; westerly generally along that boundary to the north-western corner of Section 77, Block X aforesaid; thence southerly along the western boundary of the last-mentioned section to and down the left bank of the Riwaka River to a point in line with the western boundary of Section 59, Block X aforesaid; thence again southerly across the Riwaka River to and along the last-mentioned boundary and the western boundaries of Sections 58, 48, 47, 43, 44, 45, and 14, all of Block X aforesaid, the western boundaries of Sections 13 and 1 N.R., a right line across the Motueka River, along the western boundaries of Sections 215, 245, 244, 243, 242, 241, 240, 239, 238, 237, 236, all of Block III, Motueka Survey District, crossing all intervening roads, and along the western boundaries of Sections 235, 234, 232, and 231, Block VII, Motueka Survey District, to the south-western boundary of the lastmentioned sections; thence easterly along the southern boundaries of Sections 231 aforesaid, 230, and 200, Block VII aforesaid, crossing intervening roads, to the left bank of the Moutere River; thence down the left bank of that river and along the north-western shore of the Moutere Inlet to the southern side of Harbour Road; thence easterly along that side of Harbour Road to the north-eastern shore of Moutere Inlet; thence south-easterly and north-easterly generally along the shores of that inlet to the shore of Tasman Bay; thence northerly along the shore of Tasman Bay to a point in line with the southern boundary of part Section 144, N.R. Block IV, Motueka Survey District, being a point on the boundary of the Borough of Motueka as described in the Gazette of 1939 at page 2175; thence westerly, northerly, and north-easterly generally along that borough boundary to the shore of Tasman Bay; thence northerly generally along the shore of Tasman Bay to the point of commencement.

Thirdly: All that area in the Waimea County within a radius of 2 miles of the post office in the Township of Brightwater.

Fourthly: All that area in the Waimea County within a radius of 2 miles of the post office in the Township of Wakefield.
