# THE NATURALIZATION REGULATIONS 1929, AMENDMENT NO. 6

ORDER IN COUNCIL

At the Government Buildings at Wellington, this 26th day of November, 1946

Present :

THE RIGHT HON. W. NASH PRESIDING IN COUNCIL

PURSUANT to the British Nationality and Status of Aliens (in New Zealand) Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS

1. These regulations may be cited as the Naturalization Regulations 1929, Amendment No. 6, and shall be read together with and deemed part of the Naturalization Regulations 1929\* (hereinafter referred to as the principal regulations).

2. (1) A certificate of naturalization granted in New Zealand to a married woman under section 2 of the British Nationality and Status of Aliens Act, 1914, in its application to New Zealand, and in accordance with subsection (6) of section 2 of the British Nationality and Status of Aliens (in New Zealand) Amendment Act, 1946, shall be in the Form No. 1 in the Schedule hereto.

(2) Where the names of children are to be included, paragraphs corresponding to the second and fourth paragraphs of the Form No. 2 in the First Schedule to the principal regulations shall be inserted in the certificate.

3. The Second Schedule to the Naturalization Amendment Regulations 1935 is hereby amended by inserting, after the paragraph inserted by Regulation 4 of the Naturalization Regulations 1929, Amendment No. 5, the following paragraph :---

- "The grant of a certificate of naturalization in accordance with section 2 (6) of the British Nationality and Status of Aliens (in New Zealand) Amendment Act, 1946, and the registration of the certificate and the oath of allegiance in respect thereof—
  - " (a) Where the applicant's husband is a British £ s. d. subject by naturalization 0 50 • •
  - "(b) Where the applicant's husband is a British subject by birth 0 10 0 . .
  - " (c) Where the applicant's husband is a subject
    - of a State at war with His Majesty ... 0 10 0 "

4. A declaration of alienage under subsection (3) of section 2 of the British Nationality and Status of Aliens (in New Zealand) Amendment Act, 1946, shall be in the Form No. 2 in the Schedule hereto.

5. (1) The following regulations and forms are hereby revoked :---

- (a) Regulation 4 of the principal regulations and the Form No. 7 in the First Schedule thereto :
- (b) Regulations 2 and 3 of the Naturalization Amendment Regulations 1935, and the First Schedule thereto, and the paragraph inserted in the Second Schedule thereto by the regulation published in the Gazette of the 3rd day of October, 1935, Volume III, at page 2737, and the paragraph of the Second Schedule next following the paragraph so inserted :
- (c) The above-mentioned regulation published in the *Gazette* of the 3rd day of October, 1935, at page 2737:
- (d) The Naturalization Regulations 1929, Amendment No. 4.

(2) Regulation 9 of the principal regulations, as set out in Regulation 4 of the Naturalization Regulations 1929, Amendment No. 3, is hereby amended by omitting from subclause (1) and also from subclause (2) the words "retention or", and also the words " or acquisition ".

British Nationality and Status of Aliens (in New Zealand) Amendment Act, 1946 CERTIFICATE OF NATURALIZATION

WHEREAS A. B. has applied for a certificate of naturalization, alleging with respect to herself the particulars set out below :-

And whereas I am satisfied that such a certificate may properly be granted:

Now, therefore, in pursuance of the powers conferred on me by section 2 of the British Nationality and Status of Aliens Act, 1914 (Imperial), and by subsection (2) of section 6 of the British Nationality and Status of Aliens (in New Zealand) Amendment Act, 1946, I grant to the said A. B. this certificate of naturalization, and declare that upon taking the oath of allegiance within the time and in the manner required by the regulations made in that behalf she shall, subject to the provisions of the said Acts and of the British Nationality and Status of Aliens (in New Zealand) Act, 1928, he entitled to all political and other rights, powers, and privileges, and be subject to all obligations, duties, and liabilities, to which a natural-born British subject is entitled or subject, and have to all intents and purposes the status of a natural-born British subject.
