THE NURSES REGULATIONS 1986, AMENDMENT NO. 1

ORDER IN COUNCIL

At Wellington this 30th day of November 1987

Present:

HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL

PURSUANT to paragraphs (d) and (e) of section 60 (1) of the Nurses Act 1977, His Excellency the Governor-General, acting on the advice of the Minister of Health given after consultation by that Minister with the Nursing Council of New Zealand, and by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Nurses Regulations 1986, Amendment No. 1, and shall be read together with and deemed part of the Nurses Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. Fees—The principal regulations are hereby amended by revoking regulation 27, and substituting the following regulation:

 4 27. (1) The fee payable by a nursing student on application to sit any State Examination shall be,—

- "(a) In respect of a student seeking to sit an examination to qualify as a registered general and obstetric nurse or registered comprehensive nurse, \$50:
- "(b) In respect of a student seeking to sit an examination to qualify as a midwife, psychiatric nurse, psychopaedic nurse, or enrolled nurse, \$17.

"(2) The fee payable by a nursing student on application under section 17 of the Act for registration or enrolment shall be 22.50, which shall include the issue of a certificate of registration or enrolment.

"(3) The fee payable by a person on application under section 18 of the Act for registration or enrolment shall be \$50, and a further fee of \$22.50, which shall include the issue of a certificate of registration or enrolment, shall be payable if the registration or enrolment is granted.

"(4) The fee for temporary registration or enrolment under section 31(2) of the Act shall be \$22.50.

"(5) The fee for an application for the restoration of a name to the register or roll following its removal under Part IV of the Act shall be \$73, irrespective of the number of parts of the register affected.

"(6) The fee for supplying any document for the purpose of enabling a nurse to seek registration or enrolment overseas shall be \$11.50.

"(7) The fee for an annual practising certificate issued under section 51(4) of the Act shall be \$16.

"(8) The fee for an annual practising certificate issued under section 51 (9) of the Act shall be \$32.

"(9) The fee for inspection of the register or roll shall be \$6."

3. Amount of goods and services tax not included—The fees prescribed by the principal regulations are exclusive of goods and services tax under the Goods and Services Tax Act 1985.

4. Saving—Notwithstanding the provisions of regulation 27 of the principal regulations (as substituted by regulation 2 of these regulations)—

(a) The fee payable for any practising certificate issued under section

51 (4) of the Act in respect of the year ending with the 31st day of March 1988 shall be \$13; and

(b) The fee payable for any practising certificate issued under section 51 (9) of the Act in respect of the year ending with the 31st day of March 1988 shall be \$26.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect. These regulations increase the fees payable for various matters under the Nurses Regulations 1986. The fees are exclusive of goods and services tax.

The fees payable for any practising certificate in respect of the current year (which ends with 31 March 1988) have not been increased.

Date of notification in Gazette: 3 December 1987. These regulations are administered in the Department of Health.
