

THE NURSERY REGISTRATION REGULATIONS 1954, AMENDMENT NO. 1

COBHAM, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington this 17th day of April 1958

PURSUANT to the Orchard and Garden Diseases Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Nursery Registration Regulations 1954, Amendment No. 1, and shall be read together with and deemed part of the Nursery Registration Regulations 1954* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
 - 2. The First Schedule to the principal regulations is hereby amended: (a) By omitting the words "Kawhia", "Ohura", and "Kaitieke" where
 - (a) By omitting the words "Kawhia", "Ohura", and "Kaitieke" where they appear as part of the description of the Hamilton Nursery Registration District:
 - (b) By omitting the word "Whangamomona" where it appears as part of the description of the New Plymouth Nursery Registration District:
 - (c) By omitting the words which describe the Palmerston North Nursery Registration District, and substituting the following
 - "The Counties of Waitotara, Wanganui, Waimarino, Rangitikei, Kiwitea, Pohangina, Dannevirke, Oroua, Woodville, Manawatu, Kairanga, Pahiatua, and Akitio, and that portion of the Horowhenua County lying north of a line extending due eastwards from the mouth of the Paetawa Drain to the boundary of the Horowhenua County":

(d) By omitting the words which describe the Wellington Nursery Registration District, and substituting the following words:
"The Counties of Eketahuna, Mauriceville, Castlepoint,

"The Counties of Eketahuna, Mauriceville, Castlepoint, Masterton, Wairarapa South, Featherston, Hutt, and Makara, and that portion of the County of Horowhenua not included in the Palmerston North registration district":

(e) By omitting the words which describe the Nelson Nursery Registration District, and substituting the following words:

"The Counties of Waimea, Buller, Murchison, Inangahua, Grey, Westland, and Golden Bay".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations redefine the nursery registration districts of Hamilton, New Plymouth, Palmerston North, Wellington, and Nelson.
