THE NELSON SECONDARY SCHOOLS REGULATIONS 1966

At the Government House at Wellington this 19th day of December 1966

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 57 of the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Nelson Secondary Schools Regulations 1966.
- (2) These regulations shall come into force on the 1st day of February 1967.
 - 2. These regulations shall apply to the following schools:
 - (a) Nelson College:
 - (b) Nelson Girls' College:
 - (c) Waimea College:
 - (d) Buller High School:
 - (e) Nayland College.
- 3. For the purposes of section 57 of the Education Act 1964, there shall be, in respect of the schools to which these regulations apply, a Secondary Schools Council which shall be called the Nelson Secondary Schools Council.
- 4. The Board of Governors of Nelson College and Nelson Girls' College shall be the Council of Governors of those schools incorporated under the Nelson College Act 1858, and shall consist of—

 (a) One Governor appointed by the Nelson Education Board:

 - (b) One Governor (who shall be a woman) elected by the parents of the pupils attending the schools under the control and management of the Council of Governors:
 - (c) Four Governors elected by the parents of the pupils attending the schools under the control and management of the Council of Governors:
 - (d) Two Governors elected by the associations of employers in local industries:

- (e) Two Governors elected by the associations of employees in local industries:
- (f) One Governor appointed by the Federated Farmers of New Zealand (Nelson Province) Incorporated:
- (g) One Governor appointed by the Executive of the Old Pupils' Association of Nelson College, Incorporated:
- (h) One Governor appointed by the Executive of the Old Pupils' Association of Nelson Girls' College.
- 5. (1) Except as otherwise provided in subclause (2) or subclause (3) of this regulation, the Board of Governors of Waimea College shall consist of—

(a) One Governor appointed by the Nelson Education Board:

(b) One Governor elected by the parents of the pupils attending the school, being parents who are resident in the Tahunanui School District, the Enner Glynn School District, or the Stoke School District:

(c) Two Governors elected by the parents of the pupils attending the school, being parents who are resident in the Richmond School District:

(d) One Governor elected by the parents of the pupils attending the school, being parents who are resident in the Redwoods Valley School District, the Appleby School District, the Ranzau School District, or the Hope School District:

(e) One Governor elected by the parents of the pupils attending the school, being parents who are resident in the Brightwater

School District or the Spring Grove School District:

(f) One Governor elected by the parents of the pupils attending the school, being parents who are resident in the Wakefield School District or the Foxhill School District:

(g) One Governor elected by the parents of the pupils attending the school, being parents who are not resident in any of the school districts referred to in paragraphs (b) to (f) of this subclause:

(h) One Governor co-opted by the Board of Governors itself.

(2) The Minister of Education may from time to time, by notice in the Gazette, amend the list of school districts to which paragraph (b) or paragraph (c) or paragraph (d) or paragraph (e) or paragraph (f) of subclause (1) of this regulation applies

(3) Until the 31st day of May in the year 1967, the Board of Governors of Waimea College shall, notwithstanding the foregoing provisions of this regulation, consist of the members of that Board as it was constituted immediately before the commencement of these regulations.

(4) The Waimea College Board of Governors Order 1957* and the Waimea College Board of Governors Order 1957, Amendment

No. 1†, are hereby revoked.

- 6. The Board of Governors of Buller High School shall consist of—
- (a) Three Governors appointed by the Nelson Education Board:(b) Three Governors elected by the parents of the pupils attending the school:
- (c) Two Governors elected by the associations of employers in local industries:

- (d) Two Governors elected by the associations of employees in local industries:
- (e) Two Governors elected by the Councils of the boroughs and counties of which any part is within five miles of the school:
- (f) One Governor elected by the School Committees of the State primary schools within five miles of the school.
- 7. (1) The Board of Governors of Nayland College shall consist of—

(a) One Governor appointed by the Nelson Education Board:

- (b) Six Governors elected by the parents of the pupils attending the school:
- (c) One Governor elected by the members of the School Committees of the Nelson Intermediate School and the Waimea Intermediate School:

(d) One Governor co-opted by the Board of Governors itself.

(2) The Minister of Éducation may from time to time, by notice in the Gazette, amend the list of schools to which paragraph (c) of subclause (1) of this regulation applies.

(3) The Stoke Secondary School Board of Governors Order 1965*

is hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for the establishment of a Secondary School Council in respect of the following schools, namely, Nelson College, Nelson Girls' College, Waimea College, Buller High School, and Nayland College, and prescribe the constitution of the Board of Governors of each of the schools.
