# THE NELSON SECONDARY SCHOOLS REGULATIONS 1976

### ORDER IN COUNCIL

At the Government House at Wellington this 6th day of December 1976

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 57 of the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Nelson Secondary Schools Regulations 1976.
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Application of regulations—These regulations shall apply to the following schools:
  - (a) Nelson College:
  - (b) Nelson Girls' College:
  - (c) Waimea College:
  - (d) Nayland College.
- 3. Nelson Secondary Schools Council—For the purposes of section 57 of the Education Act 1964, there shall continue to be, in respect of the schools to which these regulations apply, a Secondary Schools Council called the Nelson Secondary Schools Council.
- 4. Board of Governors of Nelson College and Nelson Girls' College—
  (1) The Board of Governors of Nelson College and Nelson Girls' College shall comprise:
  - (a) One member appointed by the Nelson Education Board:
  - (b) One member elected by the teachers of Nelson College and Nelson Girls' College:

(c) Five members (at least one of whom shall be a woman) elected by the parents of the pupils attending Nelson College and Nelson Ĝirls' College:

(d) Two members elected by the associations of employers in local

industries:

(e) Two members elected by the associations of employees in local industries:

(f) One member appointed by the Federated Farmers of New Zealand (Nelson Province) Incorporated:

(g) One member appointed by the Executive of the Old Pupils' Association of Nelson College Incorporated:

(h) One member appointed by the Executive of the Old Pupils'

Association of Nelson Girls' College.

(2) Every person who was a member of the Board of Governors of Nelson College and Nelson Girls' College immediately before the commencement of these regulations shall continue to be such a member until his term of office expires.

## 5. Board of Governors of Waimea College—(1) The Board of Governors of Waimea College shall comprise:

(a) One member appointed by the Nelson Education Board:

(b) One member elected by the teachers of Waimea College:

(c) Two members elected by parents of the pupils attending the school, being parents who are resident in the Richmond School District:

(d) One member elected by parents of the pupils attending the the school, being parents who are resident in the Redwoods Valley School District, the Appleby School District, the Ranzau School District, or the Hope School District:

(e) One member elected by parents of the pupils attending the school, being parents who are resident in the Brightwater

School District, or the Spring Grove School District:

(f) One member elected by parents of the pupils attending the school, being parents who are resident in the Wakefield School District, or the Foxhill School District:

(g) One member elected by parents of the pupils attending the school, being parents who are not resident in any of the school districts referred to in paragraphs (c) to (f) of this subclause:

(h) Two members, whose term of office shall be at the discretion of the Board of Governors, co-opted by the Board of Governors itself:

Provided that no such co-opted member shall vote on any matter relating to the co-option of any such member or the termination of the term of office of any such member.

(2) Except for the member elected under regulation 5 (1) (b) of the Nelson Secondary Schools Regulations 1966, every person who was a member of the Board of Governors of Waimea College immediately before the commencement of these regulations shall continue to be such a member until his term of office expires.

## 6. Board of Governors of Nayland College—(1) The Board of Governors of Nayland College shall comprise:

- (a) One member appointed by the Nelson Education Board:
- (b) One member elected by the teachers of Nayland College:
- (c) Six members elected by parents of the pupils attending Nayland College:
- (d) One member elected by the members of the School Committees of the Nelson Intermediate School and the Waimea Intermediate School:
- (e) One member, whose term of service shall be at the discretion of the Board of Governors, co-opted by the Board of Governors

Provided that the member so co-opted shall not vote on any matter relating to the termination of his term of office.

- (2) Every person who was a member of the Board of Governors of Nayland College immediately before the commencement of these regulations shall continue to be such a member until his term of office expires.
- 7. Revocations—The following regulations are hereby consequentially revoked:

  - (a) The Nelson Secondary Schools Regulations 1966\*:(b) The Nelson Secondary Schools Regulations 1966 Amendment No. 2†.

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations consolidate previous regulations relating to the Nelson Secondary Schools Council and the Boards of Governors of Nelson College, Nelson Girls' College, Nayland College, and Waimea College, and alter the constitution of the Board of Governors of Waimea College by dispensing with a member elected by the parents of pupils in the Tahunanui, Enner, and Stoke School Districts.
