Pursuant to section 3 of the New Zealand - Australia Free Trade Agreement Act 1965, and for the purpose of giving effect to the agreement defined in that Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. (1) This order may be cited as the New Zealand Australia Free Trade Agreement Order 1965, Amendment No. 1, and shall be read together with and deemed part of the New Zealand Australia Free Trade Agreement Order 1965\* (hereinafter referred to as the principal order).
- (2) This order shall be deemed to have come into force on the 1st day of January 1966 (being the date of the commencement of the principal order).
  - 2. The Customs Tariff is hereby amended—
  - (a) By revoking the item and rates of duty specified in the First Schedule hereto:
  - (b) By inserting in Group 061, after item 061.900.7, the item and rates of duty specified in the Second Schedule hereto.
- 3. The Second Schedule to the principal order is hereby consequentially amended—
  - (a) By revoking so much thereof as relates to item 099.090.8:
  - (b) By inserting in Group 061, after item 061.900.7, the items and rates of duty specified in the Second Schedule hereto.
