#### ORDER IN COUNCIL

At the Government House at Wellington this 30th day of November 1966

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section 3 of the New Zealand - Australia Free Trade Agreement Act 1965, and for the purpose of giving effect to the agreement defined in that Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. (1) This order may be cited as the New Zealand Australia Free Trade Agreement Order 1966.
  - (2) This order shall come into force on the 1st day of January 1967.
- 2. The Customs Tariff is hereby amended by revoking the items and rates of duty specified in the First Schedule hereto, and substituting the items and rates of duty specified in the Second Schedule hereto.

This order is made for the purpose of giving effect to the New Zealand - Australia Free Trade Agreement signed on 31 August 1965. The effect is to reduce rates of duty on frozen peas and beans from Australia.

The order comes into force on 1 January 1967.
