ORDER IN COUNCIL

At the Government House at Wellington this 7th day of December 1981

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 3 of the New Zealand - Australia Free Trade Agreement Act 1965, and for the purpose of giving effect to the Agreement defined in that Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

---

ORDER

**1. Title and commencement**—(1) This order may be cited as the New Zealand - Australia Free Trade Agreement Order 1981.

(2) This order shall come into force on the 1st day of January 1982.

**2. Tariff amended**—(1) The Customs Tariff is hereby amended by revoking so much of Part I as relates to Tariff item 42.03.039, and substituting the items and rates of duty and exemptions from duty specified in the First Schedule hereto.

(2) The Customs Tariff is hereby further amended by revoking from the column of the Customs Tariff headed 'Preferential Tariff', in respect of each Tariff item specified in the Second Schedule hereto, the expression 'Aul' and the rates of duty relating to that expression.

(3) The Customs Tariff is hereby further amended by revoking the Australian rate of duty in respect of each Tariff item specified in the Third Schedule hereto, being the rate of duty shown in the column of the Customs Tariff headed 'Preferential Tariff', and substituting in each case the rate of duty "15".

**3.
