Pursuant to section 3 of the New Zealand - Australia Free Trade Agreement Act 1965, and for the purpose of giving effect to the agreement defined in that Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the New Zealand Australia Free Trade Agreement Order (No. 2) 1969.
 - (2) This order shall come into force on the 1st day of March 1969.
- 2. The Customs Tariff (as set out in the Second Schedule to the Customs Act 1966 and heretofore modified) is hereby amended by revoking the items and rates of duty specified in the First Schedule hereto, and substituting the items and rates of duty specified in the Second Schedule hereto.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order is made for the purpose of giving effect to the New Zealand - Australia Free Trade Agreement signed on 31 August 1965. The effect of the order is to reduce, from 1 March 1969, the rates of Customs duty on certain mowers from Australia.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 27 February 1969. This order is administered in the Customs Department.
