PURSUANT to section 3 of the New Zealand - Australia Free Trade Agreement Act 1965, and for the purpose of giving effect to the agreement defined in that Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the New Zealand - Australia Free Trade Agreement Order (No. 2) 1971.

(2) This order shall come into force on the 1st day of March 1971.

2. Tariff amended—The Customs Tariff is hereby amended by revoking the items, rates of duty, and exemptions from duty specified in the First Schedule hereto, and substituting the items, rates of duty, and exemptions from duty specified in the Second Schedule hereto.

3. Revocations—(1) The Customs Tariff Amendment Order (No. 2) 1967* is hereby amended by revoking so much of the Third Schedule as relates to headings 60.03 and 61.10.

(2) The Customs Tariff Amendment Order (No. 19) 1970† is hereby amended by revoking so much of the Second Schedule as relates to Chapters 60 and 61.
