ORDER IN COUNCIL

At the Government House at Wellington this 29th day of June 1970

Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to section 3 of the New Zealand - Australia Free Trade Agreement Act 1965, and for the purpose of giving effect to the agreement defined in that Act, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the New Zealand - Australia Free Trade Agreement Order (No. 6) 1970.

(2) This order shall come into force on the 1st day of July 1970.

2. Tariff amended—The Customs Tariff (as set out in the Second Schedule to the Customs Act 1966) is hereby amended by revoking the items and rates of duty specified in the First Schedule hereto, and substituting the items and rates of duty specified in the Second Schedule hereto.

The order is effective from 1 July 1970.
