

THE NEW ZEALAND GROWN FRUIT REGULATIONS 1952, AMENDMENT NO. 4

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Orchard and Garden Diseases Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the New Zealand Grown Fruit Regulations 1952, Amendment No. 4, and shall be read together with and deemed part of the New Zealand Grown Fruit Regulations 1952* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Regulation 4 of the principal regulations is hereby amended by adding to the definition of the term "blemish" the words "or any permitted defect described in the tables set out in regulation 48 and regulation 53 of these regulations".
- 3. Regulation 47 of the principal regulations is hereby amended by revoking paragraph (b), and substituting the following paragraph:
 - "(b) Free (in the case of all varieties) from natural and unnatural russet:"
- 4. Subclause (2) of regulation 48 of the principal regulations (as amended by regulation 11 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 3) is hereby further amended as follows:
 - (a) By omitting from paragraph (a) of the table for Apples: Extra Fancy and Fancy Grade the words "40 per cent", and substituting the words "20 per cent":
 - (b) By omitting from the aforesaid paragraph (a) the words "50 per cent", and substituting the words "30 per cent":

- 7. The Second Schedule to the principal regulations (as substituted by regulation 16 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 2) is hereby amended as follows:
 - (a) By omitting the words "Cox's Orange Pippin and Cox's Early Export", and by omitting the numbers and letters appearing in each of the columns under the heading of "Minimum Colour" and opposite the words "Cox's Orange Pippin and Cox's Early Export":
 - (b) By inserting, after the words "Bledisloe Cox", the words "Cox's Orange Pippin", and by inserting in the appropriate columns under the heading of "Minimum Colour" and opposite the words "Cox's Orange Pippin", the number and letters "75", "CS", "CS", "NC", and "NC":
 - (c) By inserting, after the words "Cox's Orange Pippin" (as inserted by paragraph (b) of this regulation), the words "Cox's Early Export", and by inserting in the appropriate columns under the heading of "Minimum Colour" and opposite the words "Cox's Early Export", the numbers and letters "75", "5", "CS", "NC", and "NC":
 - (d) By inserting, after the words "Red Delicious", the words "Red Delicious (Export Grade)":
 - (e) By inserting in the column headed "XF" under the heading of "Minimum Colour" and opposite the words "Red Delicious (Export Grade)" (as inserted by paragraph (d) of this regulation) the number "75":
 - (f) By inserting in the column headed "F" under the heading of "Minimum Colour" and opposite the words "Red Delicious (Export Grade)" (as inserted by paragraph (d) of this regulation) the number "60":
 - (g) By inserting, after the word "Delicious", the words "Delicious (Export Grade)":
 - (h) By inserting in the column headed "XF" under the heading of "Minimum Colour" and opposite the words "Delicious (Export Grade)" (as inserted by paragraph (g) of this regulation) the number "75":

- (i) By inserting in the column headed "F" under the heading of "Minimum Colour" and opposite the words "Delicious (Export Grade)" (as inserted by paragraph (g) of this regulation) the number "40":
- (j) By omitting the number "20", under the heading of "Minimum Colour" and opposite the word "Delicious", and substituting the number "15".
- 8. (1) The principal regulations are hereby amended by revoking the Tenth Schedule (as substituted by regulation 22 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 3), and substituting the Tenth Schedule set out in the First Schedule to these regulations.
- (2) Regulation 22 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 3, is hereby revoked.
- 9. (1) The principal regulations are hereby amended by revoking the Eleventh Schedule (as substituted by regulation 23 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 3), and substituting the Eleventh Schedule set out in the Second Schedule to these regulations.
- (2) Regulation 23 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 3, is hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations contain miscellaneous amendments to the New Zealand Grown Fruit Regulations 1952.

Regulation 2 clarifies the definition of the term "blemish".

Regulation 3 brings the apple varieties Worcester Pearmain, McLivers Winesap, and Newtown Pippin into line with all other apple varieties in relation to russet.

Regulation 4 amends the tables in Grading Standards for Apples by decreasing russet allowances on the Sturmer Pippin Variety, by permitting a russet allowance within the limits of the stem end cavity on all varieties, by extending the allowance for ripe spot in Commercial Grade, and by instituting an allowance for Lenticel spot in all grades.

Regulation 5 enables grading standards to be varied or modified if found

necessary to meet the requirements of particular markets.

Regulation 6 amends the First Schedule to the regulations by the addition

of two further containers to the Schedule.

Regulation 7 makes a number of amendments to the Second Schedule involving changes in colour requirements in the apple varieties Cox's Orange Pippin, Red Delicious, and Delicious.

Regulation 8 amends the Tenth Schedule in regard to size of wrapping paper

to be used in wrapping apples.

Regulation 9 amends the Eleventh Schedule in regard to size of wrapping paper to be used in wrapping pears.
