THE NEW ZEALAND GROWN FRUIT REGULATIONS 1952, AMENDMENT NO. 8

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Orchard and Garden Diseases Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the New Zealand Grown Fruit Regulations 1952, Amendment No. 8, and shall be read together with and deemed part of the New Zealand Grown Fruit Regulations 1952* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Interpretation—Regulation 4 of the principal regulations is hereby amended—
 - (a) By omitting from the definition of the term "berryfruit" (as inserted by regulation 2 (a) of the New Zealand Grown Fruit Regulations 1952, Amendment No. 3) in subclause (1) the words "and gooseberries", and substituting the words "gooseberries, cape gooseberries, and blueberries":
 - (b) By omitting from the definition of the term "citrus fruit" in subclause (1) the words "and New Zealand grapefruit", and substituting the words "New Zealand grapefruit, and tangelos":

- (c) By omitting from the definition of the term "fruit" (as substituted by regulation 2 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 5) in subclause (1), the words "tree tomatoes, and passion fruit", and substituting the words "tamarillos, passion fruit, avocados, feijoas, and grapes".
- 3. Grading standards for apples—(1) Regulation 48 of the principal regulations is hereby amended—
 - (a) By omitting from the second column of the item relating to "blemish" in the table headed "Apples: Extra Fancy and Fancy Grade" and in the table headed "Apples: Good Grade" in subclause (2) the measurement "To sq. in." (as substituted by regulation 5 (1) (a) of the New Zealand Grown Fruit Regulations 1952, Amendment No. 5), and substituting the measurement "To in. sq.":
 - (b) By omitting from paragraph (a) of the item relating to "russet" in the first column of the table headed "Apples: Extra Fancy and Fancy Grade" in subclause (2) the words "Golden Delicious":
 - (c) By inserting in the appropriate columns in paragraph (a) of the item relating to "russet" in the table headed "Apples: Extra Fancy and Fancy Grade" in subclause (2), above the words "on apples of other dessert varieties", the following:

"On apples of the Golden Delicious	1

(d) By inserting in the appropriate columns in paragraph (a) of the item relating to "russet" in the table headed "Good Grade" in subclause (2), above the words "on apples of other varieties", the following:

"On apples of the Golden Delicious | 15 percent | 100."

- (2) Regulation 5 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 5, is hereby amended by revoking subclause (1).
- 4. Grading standards for pears—(1) Regulation 53 of the principal regulations is hereby amended—
 - (a) By omitting from the second column of the item relating to "blemish" in the table headed "Pears: Fancy Grade" in subclause (2) the measurement "Te sq. in." (as substituted by regulation 5 (2) of the New Zealand Grown Fruit Regulations 1952, Amendment No. 5), and substituting the measurement "Te in. sq.":

(b) By omitting from the second column of the item relating to "limb rub or leaf marks" in the table headed "Pears: Commercial Grade" in subclause (2) the measurement "½ in", and substituting the measurement "¾ in.".

(2) Subclause (2) of regulation 5 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 5, is hereby revoked.

- 5. Grading standards for peaches—Regulation 78A of the principal regulations (as inserted by regulation 14 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 3) is hereby amended by omitting from subclause (1) the words and figures "regulations 78B to 78c of these regulations", and substituting the words "this regulation".
- 6. Specification of standard packages for fruit—The First Schedule to the principal regulations (as substituted by regulation 15 (1) of the New Zealand Grown Fruit Regulations 1952, Amendment No. 2) is hereby amended by inserting an asterisk in the column headed "Peaches" opposite the number 2 in the column headed "Package No."
- 7. Colour standards for apples—The Second Schedule to the principal regulations (as substituted by regulation 3 of the New Zealand Grown Fruit Regulations 1952, Amendment No. 7) is hereby amended—
 - (a) By omitting the number "15" where it appears in the third column opposite the varieties of apples named "Delicious", "Dougherty", and "Jonathan" under the heading "Partial Red Class Local Market Grades", and substituting the number "20" in each case:
 - (b) By omitting the number "5" where it appears in the fifth column opposite the variety of apple named "Dougherty" under the heading "Partial Red Class Local Market Grades", and substituting the letters "CS".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations improve the minimum colour standards for some apples, include within the scope of the regulations some fruits not at present included, and provide for some other minor amendments.

Regulation 2 brings all fruits within the scope of the regulations by including the less common kinds of fruit, namely, cape gooseberries, blueberries, tangelos, avocados, feijoas, and grapes. The name tamarillo is substituted for tree tomato.

Regulations 3 and 4 make minor alterations to the allowance for blemish in some apples and pears.

Regulation 5 corrects an incorrect reference in regulation 78A of the principal regulations.

Regulation 6 authorises the use of the No. 2 (pear-type) case for peaches.

Regulation 7 requires a better colour standard for certain varieties of apples sold on the local market.
