1 Title

This order is the New Zealand Railways Corporation (Increased Capital of the Corporation) Order 2006.

2 Commencement

This order comes into force on the 28th day after the date of its notification in the *Gazette*.

3 Increased capital of New Zealand Railways Corporation

The capital of the New Zealand Railways Corporation is increased from \$25,620,246 to \$124,512,246.

4 Revocation

The New Zealand Railways Corporation (Increased Capital of the Corporation) Order (No 2) 2005 (SR 2005/241) is revoked.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on the 28th day after the date of its notification in the *Gazette*, increases the capital of the New Zealand Railways Corporation from \$25,620,246 (set under the New Zealand Railways Corporation (Increased Capital of the Corporation) Order (No 2) 2005 (SR 2005/241)) to \$124,512,246.
