THE OPTOMETRISTS AND DISPENSING OPTICIANS REGULATIONS 1977

ORDER IN COUNCIL

At the Government Buildings at Wellington this 12th day of April 1977

Present:

THE RIGHT HON. B. E. TALBOYS PRESIDING IN COUNCIL

PURSUANT to the Optometrists and Dispensing Opticians Act 1976, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Optometrists and Dispensing Opticians Regulations 1977.
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Interpretation—In these regulations, unless the context otherwise requires, "the Act" means the Optometrists and Dispensing Opticians Act 1976.
- 3. Qualifications that may be recognised by Board—The qualifications that may be recognised by the Board for the purposes of—
 - (a) Section 15 of the Act, shall be the qualifications described in the First Schedule to these regulations:
 - (b) Section 16 (1) (d) of the Act, shall be the qualifications described in the Second Schedule to these regulations.

- 4. Registration—(1) Every application for registration as an optometrist under section 15 of the Act, and every application for registration as a dispensing optician under section 16 (1) (d) of the Act, shall be made in form 1 in the Third Schedule to these regulations, and shall be accompanied by the prescribed fee.
- (2) Nothing in subclause (1) of this regulation shall limit or affect the right of any person to apply in writing addressed to the Board for registration as a dispensing optician under any of paragraphs (a) to (c) and paragraph (e) of section 16 (1) of the Act.
- (3) The particulars to be entered in the register of persons registered as opticians under the Act shall be as follows:
 - (a) Registration number:

 - (c) Name in full:
 - (d) Postal address:
 - (e) Qualifications.
- (4) A certificate of registration as an optometrist shall be in form 2 in the Third Schedule to these regulations.
- (5) A certificate of registration as a dispensing optician shall be in form 3 in the Third Schedule to these regulations.
- 5. Fees—(1) The fee for registration under section 15 or section 16 (1) of the Act shall be \$20.
- (2) The fee for a provisional certificate granted under section 27 (1) of the Act shall be \$2.
- (3) The fee for an annual practising certificate issued under section 40 (4) of the Act shall be \$8.
- (4) The fee for a certificate of registration issued under section 14 (8) of the Act shall be \$3.
- (5) The fee for altering any entry in a register under section 21 (2) of the Act shall be \$5.
- (6) The fee for restoring a name to a register under section 23 (4) of the Act shall be \$5.
- (7) The fee for inspection of a register under section 14 (6) of the Act shall be \$5.
- 6. Appeals—Where the Board makes a decision, in respect of any person, from which that person has a right of appeal under the Act, the Secretary to the Board shall forthwith notify that person in writing of the Board's decision and of the reasons for it.
- 7. Revocations—The Opticians Regulations 1966*, the Opticians Regulations 1966, Amendment No. 1†, and the Opticians Regulations 1966, Amendment No. 2‡ are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations consolidate and amend the Opticians Regulations 1966, consequent upon the enactment of the Optometrists and Dispensing Opticians Act 1976.

Regulation 1 relates to the Title and commencement. The regulations come into force on the day after the date of their notification in the Gazette.

Regulation 2 is interpretative.

Regulation 3 prescribes the qualifications that may be recognised by the Opticians Board for the purposes of registration as an optometris under section 15

of the Act or as a dispensing optician under section 16 (1) (d) of the Act. Regulation 4 prescribes the forms in which certain applications for registration under the Act are to be made, and in which certificates of registration are to be

Regulation 5 prescribes the fees payable in respect of the various matters referred to in the regulation.

Regulation 6 requires the Secretary to the Board to give notice of a decision of the Board and the reasons for the decision to any person entitled under the Act to appeal against the decision.

Regulation 7 consequentially revokes the Opticians Regulations 1966 and their

amendments.
