



**THE OPTOMETRISTS AND DISPENSING OPTICIANS
REGULATIONS 1977, AMENDMENT NO. 11**

ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to paragraphs (d) and (e) of section 53 (1) of the Optometrists and Dispensing Opticians Act 1976, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the advice of the Minister of Health given after consultation with the Opticians Board, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Optometrists and Dispensing Opticians Regulations 1977, Amendment No. 11, and shall be read together with and deemed part of the Optometrists and Dispensing Opticians Regulations 1977* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1992.

2. Fees—The principal regulations are hereby amended by revoking regulation 5 (as substituted by regulation 2 of the Optometrists and Dispensing Opticians Regulations 1977, Amendment No. 10), and substituting the following regulation:

“5. (1) The fee for registration under section 15 or section 16 (1) of the Act shall be \$199.

“(2) The fee for an annual practising certificate issued under section 40 (4) of the Act shall be \$141.

“(3) The fee for a certificate of registration issued under section 14 (8) of the Act shall be \$30.

“(4) The fee for altering any entry in a register under section 21 (2) of the Act shall be \$12.

“(5) The fee for restoring a name to a register under section 23 (4) of the Act shall be \$43.

“(6) The fee for inspection of a register under section 14 (6) of the Act shall be \$48.

“(7) The fee for supplying any document for the purpose of enabling an optician to seek registration outside New Zealand shall be \$30.”

3. Fees inclusive of goods and services tax—The fees fixed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

4. Revocation—The Optometrists and Dispensing Opticians Regulations 1977, Amendment No. 10 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1992, prescribe a new and increased scale of fees payable under the Optometrists and Dispensing Opticians Act 1976.

The fees prescribed are inclusive of goods and services tax.
