ORDER

1. Title and commencement—(1) This order may be cited as the Otago Area Health District (Triennial General Election and Boundaries) Order 1989.

(2) Except as provided in clause 10 (3) of this order, this order shall come into force on the 18th day of July 1989.

2. Abolition of Otago Area Health District—The Otago Area Health District is hereby abolished as from the close of the 10th day of December 1989 (being the 57th day after polling day for the next triennial general election of members of local authorities as prescribed by section 4 of the Local Elections and Polls Act 1976).

3. Abolition of South Otago Hospital District—The South Otago Hospital District is hereby abolished as from the close of the 10th day of December 1989 (being the 57th day after polling day for the next triennial general election of members of local authorities as prescribed by section 4 of the Local Elections and Polls Act 1976).

4. Constitution of Otago Area Health District—A new area health district, under the name of the Otago Area Health District, is hereby constituted on the 11th day of December 1989 (being the 58th day after polling day for the next triennial general election of members of local authorities as prescribed by section 4 of the Local Elections and Polls Act 1976).

5. Boundaries for triennial general election—It is hereby declared that, for the purposes of the triennial general election of members of local authorities to be held on the 14th day of October 1989 (as required by section 4 of the Local Elections and Polls Act 1976), the boundaries of the Otago Area Health District (as constituted by clause 4 of this order) shall be deemed to be the boundaries of the land included within the Dunedin City, the Waitaki District, the Central Otago District, the Clutha District, and the Wanaka Ward of the Queenstown-Lakes District (all of which districts are districts of territorial authorities named in the First Schedule to the Local Government Act 1974 (as substituted by clause 2 of the Local Government Act First Schedule Order (No. 2) 1989*)).

6. Boundaries on 58th day after polling day—It is hereby declared that, on the 58th day after polling day for the triennial general election referred to in clause 5 of this order, the boundaries declared by that clause shall become the boundaries of the Otago Area Health District.

7. Constituent districts—It is hereby declared that, for the purposes of the triennial general election referred to in clause 5 of this order,—

- (a) The area comprising the Waitaki District and the Waikouaiti Coast Ward of Dunedin City shall be a constituent district of the Otago Area Health District; and
- (b) The area comprising the Central Otago District and the Wanaka Ward of the Queenstown-Lakes District shall be a constituent district of the Otago Area Health District; and
- (c) The area comprising the wards of Dunedin City known as the North Ward, the Port Chalmers Ward, and the Central Ward shall be a constituent district of the Otago Area Health District; and
- (d) The area comprising the wards of Dunedin City known as the East Ward, the West Ward, the St Kilda Ward, and the Green Island Ward shall be a constituent district of the Otago Area Health District; and
- (e) The area comprising the Clutha District and the wards of Dunedin City known as the Mosgiel Ward, the Taieri Ward, the Saddle Hill Ward, and the Strath-Taieri Ward shall be a constituent district of the Otago Area Health District.

8. Number of representatives of constituent districts—The number of representatives on the Otago Area Health Board of each constituent district declared by clause 7 of this order shall be as specified in the Schedule to this order.

9. Conduct of elections—(1) For the purpose of the conduct of elections held within the constituent district declared by clause 7 (a) of this order,—

- (a) The Oamaru Borough Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
- (b) The Waitaki District Council (as constituted by the Local Government (Otago Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.

(2) For the purpose of the conduct of elections held within the constituent district declared by clause 7 (b) of this order,—

- (a) The Alexandra Borough Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
- (b) The Central Otago District Council (as constituted by the Local Government (Otago Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.

(3) For the purpose of the conduct of elections held within the constituent district declared by clause 7 (c) of this order,—

(a) The Dunedin City Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections

held within that constituent district before the 1st day of November 1989; and

(b) The Dunedin City Council (as constituted by the Local Government (Otago Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.

(4) For the purpose of the conduct of elections held within the constituent district declared by clause 7 (d) of this order,—

- (a) The Dunedin City Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
- (b) The Dunedin City Council (as constituted by the Local Government (Otago Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.

(5) For the purpose of the conduct of elections held within the constituent district declared by clause 7 (e) of this order,—

- (a) The Bruce District Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
- (b) The Clutha District Council (as constituted by the Local Government (Otago Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.

10. Revocations—(1) The Otago Area Health District Order 1988* is hereby revoked.

(2) The Otago Area Health District Order 1988, Amendment No. 1⁺ is hereby revoked.

(3) This clause shall come into force on the 11th day of December 1989.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order—

- (a) Abolishes the Otago Area Health District and the South Otago Hospital District as from the close of 10 December 1989; and
- (b) Constitutes on 11 December 1989 a new area health district under the name of the Otago Area Health District; and
- (c) Declares the boundaries that are to be deemed to be the boundaries of the Otago Area Health District for the purposes of the triennial general election of members of local authorities to be held on 14 October 1989; and
- (d) Declares the areas that are to be constituent districts of the Otago Area Health District for the purposes of that election.

On 11 December 1989 (the 58th day after polling day for that election) the boundaries so declared will become the boundaries of the Otago Area Health District and the constituent districts so declared will become constituent districts of that area health district.

At the triennial general election to be held on 14 October 1989, no election will take place in relation to the Otago Area Health Board and the South Otago Hospital Board (the Boards of the districts to be abolished). The representatives on those Boards at the close of the day before polling day will continue to hold office until the close of 10 December 1989.
