

# THE ORGANISATION AND INSPECTION OF STATE PRIMARY SCHOOLS REGULATIONS 1963, AMENDMENT NO. 1

#### ORDER IN COUNCIL

At the Government House at Wellington this 29th day of June 1981

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Organisation and Inspection of State Primary Schools Regulations 1963, Amendment No. 1, and shall be read together with and deemed part of the Organisation and Inspection of State Primary Schools Regulations 1963\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the

date of their notification in the Gazette.

2. Interpretation—The principal regulations are hereby amended by revoking regulation 2, and substituting the following regulation:

"2. In these regulations, unless the context otherwise requires,—

- "'Head Teacher', in relation to to an intermediate department attached to a secondary school, means the Principal of that secondary school:
- "'Senior Inspector' means the Senior Inspector of Primary Schools for the appropriate Education District:
- "'State primary school' includes an intermediate department attached to a secondary school."

3. Primary teacher in intermediate department may be directed to undertake secondary duties—The principal regulations are hereby amended by inserting, after regulation 9, the following regulation:

"9A. To the extent that, in the opinion of the Head Teacher of an intermediate department attached to a secondary school, by reason of—

"(a) An absence of teachers; or

"(b) An emergency; or

"(c) The special qualifications or experience in an area of the curriculum of that school of any assistant teacher employed in that department—

it is desirable for an assistant teacher employed in that department (or, as the case requires, that teacher) to carry out any teaching or supervisory duties in that school, he may direct that assistant teacher to undertake those duties; and in that case that teacher shall undertake those duties accordingly."

- 4. Amendments consequential on abolition of Maori schools—(1) Regulation 3 (2) of the principal regulations is hereby amended by omitting the words "or Maori school".
- (2) Regulation 10 of the principal regulations is hereby amended by revoking subclause (2).
- (3) Regulation 21 (1) of the principal regulations is hereby amended by omitting the words "State primary school, registered private school, correspondence school of the Department of Education, intermediate school or department, or Maori school", and substituting the words "State primary school or private primary school".

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for an assistant teacher employed in an intermediate department attached to a secondary school to undertake duties in that secondary school if the Principal directs him to do so. The opportunity has been taken to omit references to Maori schools, which have been abolished.
