# THE ORGANISATION AND INSPECTION OF STATE PRIMARY SCHOOLS REGULATIONS 1963, AMENDMENT NO. 2

#### ORDER IN COUNCIL

### At Wellington this 21st day of July 1986

#### Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL PURSUANT to the Education Act 1964, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Organisation and Inspection of State Primary Schools Regulations 1963, Amendment No. 2, and shall be read together with and deemed part of the Organisation and Inspection of State Primary Schools Regulations 1963\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 15th day of August 1986.

**2. Interpretation**—(1) Regulation 2 of the principal regulations (as substituted by regulation 2 of the Organisation and Inspection of State Primary Schools Regulations 1963, Amendment No. 1) is hereby amended by omitting the definition of the term "Head Teacher", and substituting the following definition:

\*S.R. 1963/46 Amendment No. 1: S.R. 1981/161 "'Principal' means the Principal of a State primary school; and-

"(a) In relation to a State primary school, means the Principal of that school; and

"(b) In relation to an intermediate department attached to a secondary school, means the Principal of that secondary school:".

(2) The principal regulations are hereby consequentially amended by omitting the expression "Head Teacher", wherever it appears, and substituting, in each case, the word "Principal".

**3. New regulations inserted**—The principal regulations are hereby amended by inserting, after regulation 8, the following regulations:

"8A. **Duties of Deputy Principals**—Subject to any general or particular directions of the Principal, the Deputy Principal of a school shall—

"(a) Be responsible to the Principal for-

"(i) The effective day to day management of; and

"(ii) The programmes of work and progress of pupils in,-

- that part of the school supervised by the Deputy Principal; and "(b) Have special responsibility for staff and pupil welfare throughout the school; and
- "(c) While maintaining the established policies of the school, act in place of the Principal if the Principal is temporarily absent.

"8B. Duties of Assistant Principals—Subject to any general or particular directions of the Principal, the Assistant Principal of a School shall—

"(a) Be responsible to the Principal for-

"(i) The effective day to day management of; and

"(ii) The programmes of work and progress of pupils in,-

that part of the School to be supervised by the Assistant Principal; and

"(b) Act in place of the Deputy Principal if the Deputy Principal is temporarily absent."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Organisation and Inspection of State Primary Schools Regulations 1963 so as to specify the duties of Deputy and Assistant Principals.
