THE OYSTER FISHING REGULATIONS 1946, AMENDMENT NO. 4

ORDER IN COUNCIL

At the Government Buildings at Wellington this 11th day of August 1969

Pursuant to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Oyster Fishing Regulations 1946, Amendment No. 4, and shall be read together with and deemed part of the Oyster Fishing Regulations 1946* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*, and shall continue in force until the 19th day of September 1969 and shall then expire with that date and thereupon be deemed to be revoked.
- 2. Close season in respect of part of Southern Area—(1) Regulation 15 of the principal regulations (as amended by the Oyster Fishing Regulations 1946, Amendment No. 3) is hereby amended by revoking subclause (2).

(2) The Oyster Fishing Regulations 1946, Amendment No. 3, is

hereby consequentially revoked.

(3) While these regulations continue in force, the said regulation 15 shall be read as if the following subclause were added as subclause (2):

"(2) Notwithstanding the provisions of subclause (1) of this regulation, the period commencing with the 1st day of September 1969 and ending with the 19th day of that month shall be deemed not to be a close season in that part of the Southern Area lying south of latitude 46° S; and

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations revoke the Oyster Fishing Regulations 1946, Amendment No. 3, which prescribe a close season in respect of the Foveaux Strait-Stewart Island oyster beds for the period commencing with 21 May 1969 and ending with 31 August 1969. The effect of regulation 2 is to provide for an open season for the taking of oysters from those beds from the commencement of these regulations up to and including 19 September 1969. Normally the season would end on 31 August 1969.
